Minutes of the 1568th Meeting of Rotary Club of Calcutta North East held at The Antelope, 3, Ho Chi Minh Sarani, Kolkata - 700071 on 29.12.22 at 8.00 PM.

- → President Rtn Ramprasad Chattopadhyay called the meeting to order, followed by the national anthem.
- ◆ President informed that the next health checkup camp (Project Ujjivan) will be set up on 8th January 2023.
- President informed that the application for the EIRWT Grant will be submitted the next day.
- President said that we wished to complete the solar panel project at the Ashram in Kapastikuri which has been approved by the Board by 31st January 2023.
- ◆ The club members observed one minute of silence as a sign of respect to the departed soul Rtn Ananda Gopal Sankhanidi.
- The members decided that the club picnic will be on 5th February 2023.
