Some salient Provisions

The Purpose of Rotary Club are- to carry out successful service projects and contribute to the advancement of Rotary by strengthening membership. Club shall hold a regular weekly meeting on the day and time set out in the bylaws.

Board Meetings:- Within 30 days after Board meeting, written minutes should be available to all members.

The club shall be composed of adult persons who demonstrate Good character, integrity, leadership; possess good reputation within their business, profession, and/or community, and are willing to serve in their community.

Each member should attend club's regular meetings and engage in club's service projects. Member shall be counted as attending a regular meeting if the member present for at least 60 percent of the meeting.

Member's absence shall be excused if the sum of member's age and years of membership in one or more clubs is 85 years or more, the member has been a Rotarian for at least 20 years, and the member has notified the club secretary in writing of a desire to be excused from attendance.

Every member shall pay annual dues as prescribed in the bylaws.. If the dues are not paid within 10 days after the notification, the Board may terminate membership, at its discretion.

Any member who fails to pay dues within 30 days after they are due, shall be notified in writing by the Secretary. If the dues are not paid within 10 days after the notification, the board may terminate membership' at its discretion. TERMINATION FOR NON-ATTENDANCE- a member must attend or make up at least 50 %. A member who fails to attend as required, may be terminated unless the board consents to the non-attendance for good cause,
