#### **November is ROTARY FOUNDATION MONTH**

#### So what is The Rotary Foundation??

The Rotary Foundation is a non-profit corporation that supports the efforts of Rotary International to achieve world understanding and peace through international humanitarian, educational, and cultural exchange programs. It is supported solely by voluntary contributions.

The foundation was created in 1917 by Rotary International's sixth president, **Arch C. Klumph**, as an endowment fund for Rotary "to do good in the world." It has grown from an initial contribution of US\$26.50 to more than US\$1billion. It has one of the largest and most prestigious international fellowship programs in the world.

#### Polio eradication

#### **PolioPlus:**

Rotarians have mobilized by the hundreds of thousands to ensure that children are immunized against this crippling disease and that surveillance is strong despite the poor infrastructure, extreme poverty and civil strife of many countries. The Polio Plus program has been promoted by **Sergio Mulitsch di Palmenberg** President and founder of Rotary Club Treviglio e Pianura Bergamasca in Rome during the June 1979 3H Promotion convention. Mulitsch, thanks to the 204 District Governo VALMIGI, began the fundraising and, thanks to the own professionally in packaging technology solved the temperature shipping issue, starting the first immunization campaign in the Philippines in 1980. Since the PolioPlus program's inception in 1985 more than two billion children have received oral polio vaccine. To date, 209 countries, territories

and areas around the world are polio-free. As of January 2012, India was declared polio free for the first time in history, leaving just Pakistan, Nigeria and Afghanistan with endemic polio.[3] As of June 2011, Rotary has committed more than U\$\$850 million[4] to global polio eradication. Rotary has received \$355 million in challenge grants from the Bill and Melinda Gates Foundation. The Bill and Melinda Gates Foundation: Rotary committed to raising \$200 million by June 30, 2012, and met that goal by January 2012. This represents another \$555 million toward polio eradication.

#### **Polio Plus Fund:**

Grants supported out of the PolioPlus Fund that are primarily geared towards national level and supra-national efforts. For example, National PolioPlus Committee chairs or a major partner agency, such as the World Health Organization or UNICEF may apply for these funds.[7] Support is available for eradication efforts in polio-endemic, recently endemic, and high-risk countries, including National Immunization Days, poliovirus transmission monitoring, and other activities.

PolioPlus Partners is a program that allows Rotarians to participate in the polio eradication effort by contributing to specific social mobilization and surveillance activities in polio-endemic countries. In 2003–2004, grants were approved in Africa and South Asia for a total of \$330,000.

#### **Humanitarian grants programs**

#### **Disaster Recovery:**

Facilitates club efforts to support disaster preparedness and recovery.

#### **District Simplified Grants:**

Support for short-term service activities or humanitarian endeavors of districts in communities locally or internationally. This program began in 2003–2004 and, projects in 44 countries at a cost of US\$5.2 million were awarded.

#### Health, Hunger and Humanity (3-H) Grants:

Support for large-scale, two- to four-year projects that improve health, alleviate hunger, or promote human development. Since 1978, projects in 74 countries have been funded at a cost of US\$74 million. As of 1 July 2009, the foundation will no longer award 3-H grants, with the exception of projects being developed to support water and sanitation projects in Ghana, the Philippines, and the Dominican Republic.

#### 3-H Planning Grants:

Support for the planning activities of Rotary clubs and districts designing 3-H projects of a significant size and impact. Also in moratorium in conjunction with 3-H Grants program.

#### **Matching Grants:**

Provide matching funds for the international service projects of Rotary clubs and districts. Since 1965, more than 20,000 Matching Grants projects in 166 countries have been funded at a cost of more than US\$198 million.

#### **Educational programs**

#### **Scholarships:**

Founded in 1947, the Ambassadorial Scholarships program was the largest non-governmental and most international scholarship program in the world. Scholars studied in a country other than their own where they serve as unofficial ambassadors of goodwill. Over 37,000 scholars from some 110 countries received scholarships at a cost of almost US\$446 million. The program ended in 2013. Scholarships are now funded by district and global grants and are offered directly through Rotary clubs.

#### Group Study Exchange (GSE):

These annual awards are made to paired Rotary districts to provide travel expenses for a team of non-Rotarians from a variety of vocations. Rotarian hosts organize a four- to six-week itinerary of educational and cultural points of interest. Since 1965, almost 48,000 individuals in more than 11,000 teams from more than 100 countries have participated at a cost of US\$85 million.

#### **Rotary Peace Fellowships:**

Up to 100 fellows are selected every year in a globally competitive process based on personal, academic, and professional achievements. Fellows earn a master's-level degree or a professional development certificate in peace and conflict studies at one of six Rotary Peace Centers at leading universities in Australia, England, Sweden, Japan, the United States and Thailand.

#### **Rotary Grants for University Teachers:**

Awarded to faculty members to teach in a developing nation for three to ten months. Since 1985, 377 university teachers have taught at a college or university in a developing country. As of 1 July 2009, the foundation has discontinued this program.

The Rotary Foundation transforms your gifts into projects that change lives both close to home and around the world. As the charitable arm of Rotary International, we tap into a global network of Rotarians who invest their time, money, and expertise into our priorities, such as eradicating polio and promoting peace. Foundation grants empower Rotarians to approach challenges such as poverty, illiteracy, and malnutrition with sustainable solutions that leave a lasting impact.

Strong financial oversight, a stellar charity rating, and a unique funding model mean that we make the very most of your contribution. Give and become a part of Rotary's life-changing work!

The collective leadership and expertise of our 1.2 million members helps us tackle some of the world's biggest challenges, locally and globally. We are united by common values and vision for the future as we sharpen our focus with targeted specific causes that will reach communities most in need.

#### \*HISTORY OF THE ROTARY FOUNDATION

\*At the 1917 convention, outgoing RI President Arch C. Klumph proposed to set up an endowment "for the purpose of doing good in the world." In 1928, it was renamed The Rotary Foundation, and it became a distinct entity within Rotary International.

#### \*GROWTH OF THE FOUNDATION

In 1929, the Foundation made its first gift of \$500 to the International Society for Crippled Children. The organization, created by Rotarian Edgar F. "Daddy" Allen, later grew into Easter Seals. When Rotary founder Paul Harris died in 1947, contributions began pouring in to Rotary International, and the Paul Harris Memorial Fund was created to build the Foundation.

#### \*EVOLUTION OF FOUNDATION PROGRAMS

\*1947: The Foundation established its first program, Fellowships for Advance Study, later known as Ambassadorial Scholarships.

\*1965-66: Three programs were launched: Group Study Exchange, Awards for Technical Training, and Grants for Activities in Keeping with the Objective of The Rotary Foundation, which was later called Matching Grants.

- \*1978: Rotary introduced the Health, Hunger and Humanity (3-H) Grants. The first 3-H Grant funded a project to immunize 6 million Philippine children against polio.
- \*1985: The PolioPlus program was launched to eradicate polio worldwide.
- \*1987-88: The first peace forums were held, leading to Rotary Peace Fellowships.
- \*2013: New district, global, and packaged grants enable Rotarians around the world to respond to the world's greatest needs.
- \*Since the first donation of \$26.50 in 1917, the Foundation has received contributions totaling more than \$2.5 billion.



#### **Rotary Foundation (India)**

Rotary Foundation (India) supports selected programs and projects of The Rotary Foundation of Rotary International. Rotary Foundation (India) ("RFI") is a society registered under the Societies Registration Act of 1860 on 22nd February 1988. RF(I) provides Indian donors with a tax rebate of 50% under Section 80-G of the Income Tax Act 1961. These contributions to RF(I) are also eligible for Donor recognition from TRF.

Rotary Foundation (India) is registered under Foreign Contribution and Regulation Act (FCRA) with the Ministry of Home affairs, Government of India. Rotary Foundation (India) also has a CBDT approval for Intercontinental Medicare projects to be undertaken in the continent of Africa and the developing countries of Asia under section 11(1) (c) of the Income Tax Act 1961.

Rotary Foundation (India) is registered with Darpan (An initiative of NITI Ayog, Govt. of India)

Also registered with BSE Sammaan [An initiative by Confederation of Indian Industry (CII), Bombay Stock Exchange (BSE) and Indian Institute of Corporate Affairs (IICA)]



#### **Brief Timeline of the Initial Years of Rotary**

#### 1905: Rotary begins

Attorney Paul P. Harris convenes the first Rotary meeting on 23 February in Chicago, Illinois, USA. Harris envisions a professional club that brings together local men from a variety of vocations

#### 1910: Clubs form an association

Members representing 16 Rotary clubs gather at the first Rotary Convention, in Chicago in 1910. They create the National Association of Rotary Clubs of America, adopt a constitution and

bylaws for the organization, and elect a board of directors. As members of the association, Rotary clubs remain autonomous but share core values.

#### FOR A CHARTER CONVENTION

To Adopt a Constitution and Thereby Establish

A NATIONAL ASSOCIATION OF ROTARY CLUBS OF AMERICA

ANNOUNCES that said Convention will be held as follows:

PLACE—In the City of Chicago, State of Illinois.

(Details as to headquarters, meeting places, etc. will be announced later.)

DATE—Monday, Tuesday and Wednesday, August 15th, 16th, 17th, 1910.

(Details as to program for each day's business and entertainment will be published later.)

REPRESENTATION—Each local Rotary Club recognized by the National Board of Commissioners (or by the Convention when in session) shall be entitled to participate in the business of the Convention and cast a vote therein upon the basis of one vote for each fifty (50) members or major fraction thereof.

DELEGATES—Each participating Club shall decide for itself how many delegates it will send to the Convention and how its delegates shall be selected and in what manner such delegation shall cast the vote which that Club is entitled to cast. That is to say: Suppose a certain Club has 285 members and therefore is entitled to six (6) votes in the Convention; that Club may send six delegates, or it may send twenty delegates (or any other number,) or it may send only one delegate; in any case the representative, or representatives, of that Club shall cast six votes in the Convention. All delegates shall have the privileges of the floor and shall be eligible to serve as officers and committeemen of the Convention.

ENTERTAINMENT—A splendid program of entertainment will be provided by our hosts—Rotary Club of Chicago.

(Details later.)

RAILROAD RATES—While it has not been possible to secure any special rates from the railroads for our Convention, attention is called to the fact that the Rotary Convention will occur in the week following the great Triennial Conclave of the Knights Templar in Chicago, and any one who is able to start so as to arrive in Chicago not later than the 8th of August can avail himself of the special Triennial Conclave rates which will be in effect during the early days of August. Full information as to these rates can be obtained from your local railroad offices. Delegates who are Knights Templar will find the time scheduled particularly fortunate as they can avail them selves of the cheap rates and at the same time attend both functions. It is also thought that many who are not Knights Templar will desire to avail themselves of the opportunity afforded to visit Chicago during this gala week.

ALL ROTARY CLUBS are requested to publish and circulate the information contained in this Call to all their members and take steps to assure the attendance of as large delegations as possible at the First National Convention.

#### RATIONAL ROTARIANISM

By Paul P. Harris.

National President.

National President,

If by interposition of Providence I some day were to find myself standing on a platform in some great Coliseum looking into the eyes of every living Rotarian, and were to be told that I could have ene word to say, without an instant's hesitation and at the top of my voice, I would shout "Toleration!"

If was in pursuit of it that the pilgrim fathers embanied in their frail craft upon the stormy waters. It was from the chrysalis toleration that lustrous winged liberty, awakened by the music of the sweetest toned bell on earth, sprang and floated away that July day in Philadelphia, while the world dreamed and wondered.

If this Rotary of ours is destined to be more than a mere passing thing, it will be because you and I have learned the importance of bearing with each other's infimities, the value of toleration.

Rotary is entirely without precedent in the history or cultions. We have had no rules except such as have been gathered from the creative imagination of the men who have been responsible for our destinies. As mariners, long before the invention of the compass, successfully navigated perilems and unknown sens by the guidance of the compass, successfully navigated perilems and unknown sens by the guidance of the stars, so tacy, the forefathers of Rotary, observing the rules that have from time immemorial influenced the lives of men, salifully guided their craft in perilous, unknown and trying eircumstances. May we nover, in time to come, depart from the safe course of rational toleration and humane consideration of the convictions of others.

If I, as above said, were by Providence to be placed on a platform in some great collectum where I had the eye nod the thought of every Rotarian on earth, I would like to propound this question: "What is the philosophy of Rotary as you understand it?"

In my mind's ever leam see a multi-tude of hands go up and I can see my self realizing the hopelessness of arriving an accurate conclusions through process of haphazard individual expressions of opinion.

However, I might well ask another

opinion, However, I might well ask another

However, I might well ask another question:

"How many believe that Rotary philosophy is to give and to influence business to and to get business from fellow members and persons influenced by them!" The result would probably be that all, except a very few, would arise.

To narrow the question down to an even finer point, I might ask: "How many, if any, of those present think it either dishonorable or unethical to join a club for business purposes?" That shot would reach home. A few might arise amid numerous murmurs of disapproval.

However, if such result were to be, I would think it but fair to give the minority a hearing. I would ask, "Mr. Ethical Standard" to express his views. I can readily anticipate them. He would just about say:

"This business getting feature of Botary looks dangerous to me. What will people think of wi! I um a member of several clubs and societies all of which rank high in our city and I know it to be a fact that in one of them at least soliciting business is strictly prohibited and in all it is tabooed. In my personal estimation it constitutes the personifection of bad form. Clubs are meant for club purposes and not for business purposes. It a man is to continue to grind away at business all they and all night, why does he not remain at his desk or store! One of the chief purposes of clubs is to take one away from business cares, to afford one rest and recreation. I have lived for forty years now and have never in all my life known or heard of a club whose very constitution and by-laws violate this fundamental priciple."

Here a cynic might interpose, "Did the thought that your great grandfather lived all of his life without ever having been on a train of cars, ever enter your head? And if so, did you ever kappen to arrive at the conclusion that your grandfather lived all the did not be suffered to be my good fortune to choose. I would certainly ask to hear from "Mr. Vigorously Definite" on the subject. Prom what I know of the man, I can tell you in advance many of the points he would score. Some of his words might he:

"Whether or not it is dishonorable to join a club for business purposes, depends upon the club, its principles and what one professes to join it for. There is no more culpability about joining a business club for business purposes, an arthetic club for sheller purposes, or a political club for the acquisition of a pull.

"If any one tells you that it is reprehensible to try to make a dollar or two for the wife and hables from club associations, tell that person that some foreign substance has gotten into his carburetor. Legitimate business transactions are

profitable to both sides. If it was necessary to skin a man every time one does business with bim, there might be senson in the view point, but I know my goods, and I know that I am doing the other fellow just as great a tavor as I am doing myself, when I give him a chance to trade with me. The trouble with the philosophy of Mr. Ethical Standard is that he has gleaned the information that in certain particular clubs of which he is a member, business soliciting is either prohibited or tabooed, and the moment he gleaned that information his lights went out.

"If they had stayed lit a second lenger he could not have escaped getting rationality back of his conclusions. He would have come to a realization that straightforward husiness is never what the lawyers would sail manum per so, that is, wrong of itself. It may be what they would call malum prohibitum, that is, wrong because prohibited or made wrong by some rule of conduct which we are bound by law or by our ouths to respect.

"No true Botarian ever permits his tail feathers to droop just because some outsider makes the remark that business is not of the key notes of Rotary. Then he when the gots cocky. Businessal Yes, of confree. Why not! I'm proud of if, aren't you! If your business is good enough to talk in your shop, and even your home is not too sacred for its consideration, on what theory do you exclude it from your chab!

For us to be ashamed of business would be uppardonable is view of what he can

For us to be ashamed of business would be unpurdonable in view of what business has done for each of us. With nearly equal reason and propriety a man might be ashamed of his own father or mother. Basiness is the mainspring of civilization, Cut business out and the great hands of time will whire buckwards to acons B. C.'

I never like to have a good subject exhausted at one brief hearing and so I would give an instant's thought to the possible proximity of the rock "Intolernace" and modify my question. I would ask: "Does Retary stand for any thing beyond or besides giving business and influencing business to fellow members and persons influenced by them!"

#### **PROGRAMS**

(All figures are as of 30 June 2021 and in U.S. dollars.)

Since 1988, Rotary and our partners have immunized nearly 3 billion children against polio.

As of June 2021, Rotary had committed more than \$2.2 billion to global polio eradication.

We're still working to eliminate the wild poliovirus in the last two countries where it remains endemic and to ensure that it does not return elsewhere. In 2020-21, program awards, including PolioPlus Partners grants, totaled \$152.9 million.

Global grants fund large-scale international activities with sustainable, measurable results that support Rotary's areas of focus. Activities include humanitarian projects, scholarships, and vocational training teams. In 2020-21, the Foundation approved 2,066 global grants, and program awards totaled \$130.0 million.

#### District grants

District grants support small-scale, short-term projects related to the Foundation's mission. In 2020-21, the Foundation approved 467 district grants, and program awards totaled \$31.1 million.

#### Disaster response grants

Rotary's disaster response grants support relief and recovery efforts in areas that have been affected by natural disasters within the past six months. In 2020-21, the Foundation approved 55 disaster response grants, and program awards totaled \$3.1 million.

#### **Rotary Peace Centers**

Each year, the Foundation supports the training of peace fellows at Rotary Peace Centers, where they earn master's degrees or professional development certificates. Since 2002 1,487 fellows from more than 115 countries have participated. In 2020-21, 117 fellows from 63 countries began their studies at the Rotary Peace Centers, and program awards for the fellows and centers totaled  $$4.4 \mathrm{million}$ .

#### Programs of Scale grants

Programs of Scale grants empower Rotary members to work with experienced partners to implement large-scale, high-impact projects over three to five years to benefit a large number of people. The member-led Partners for a Malaria-Free Zambia program was awarded the 2020-21 grant of \$2 million, which was matched by \$4 million in funding from our partners.


For the 12th consecutive year, The Rotary Foundation has received the highest rating - four stars from Charity Navigator, an independent evaluator of charities in the U.S.

The Foundation earned the recognition for demonstrating both strong financial health and commitment to accountability and transparency.


Only one percent of the organizations Charity Navigator evaluates have received 12 consecutive 4-star evaluations.
