LIBRARY SET UP BY OUR INTERACT CLUB



CERVICAL CANCER VACCINATION CAMP HELD ON 21st NOVEMBER 2023



SUPPORTED BY ROTARY THE CANCER FOUNDATION in presence of Hon. Secretary Rtn Ajay Narayan On 21 November 2023 our Club held a Cervical Cancer Vaccination Camp for giving the second dose of vaccine to the girls of DAV School, Vikaspuri.

Present at the Camp was Rtn PP Ajay Narayan, Honorary Secretary, Rotary Cancer Foundation.

At the Camp 56 girl students (including children with special needs) were vaccinated. These 56 girls are now 100% vaccinated against 5 types of cancer.

At the Camp we distributed 100 notebooks, 150 sanitary napkins and packets of snacks to students who participated in the Camp.

Gifts were also given to the Medical Team from BLK Hospital, that conducted the vaccinations, and to the teachers looking after the Interact Club of DAV School.



The event was a success but there were some initial hiccups as well. The porter who was carrying vaccines met with accident enroute and the vacines could only reach us after 3 hours of waiting. The BLK Hospital Team waited patiently for almost 4.5 hours which was very



commendable on their part and highly appreciable. Thank You team BLK!



the plants to promote understanding of sustainable practices by emphasizing the long-term commitment required to care for planted trees and their impact on future generation.





REGULAR MEETING HELD ON TUESDAY 21st NOVEMBER 2023

Rtn President Harinder Arora called the 392nd Meeting of Rotary Club of Indraprastha-Okhla to Order at 7:40 PM on Tuesday 21 November 2023 at Friends Club.

Members sang the National Anthem. Rtn PP Sunil Bandula read out the 4-Way Test.



The President welcomed the Guest Speaker Advocate Ms Sheetal Mishra and said that she would be speaking on "Making Will and Bights of Lagorithm"

Rights of Legal Heir".

Rtn Rohit Gupta introduced the Guest Speaker.

Since Advocate Sheetal Mishra spoke on a very important legal issue concerning each one of us, it is considered important for our members that we reproduce each of the points made by her in appropriate legal language.

At the very outset Ms Sheetal Mishra made the observation that for us Will planning' is hardly seen as a part of financial management. She explained that even before we study the importance of a Will or its planning, let us first understand what it actually is.



What is a Will: Will defined in Indian Succession Act 1925 Sec 2(h) states - The legal declaration of the intention of a testator with respect to his property which he desires to be carried into effect after his death.

Testator: One who has made the Will.

Attestor: One who attests the Will in presence of testator.

Executor: One who executes the Will.

It is a legal document that names individual/individuals who would receive the property – (movable and immovable – Shares, Lockers, bank account, car and immovable property is for property) and possessions after his/her death. The document can be revoked, modified or substituted by the person executing it at any point during his/her lifetime and the last will be final and binding.

Requisites of a valid Will

The testator (legator) must be competent to make the Will - Not a minor, Of sound mind – capable of forming a judgment and not affected by intoxication and illness or from any other cause, eg fraud, coercion, etc.

- The legatee (testatrix) must be competent to take the legacy or bequest.
- The testator must be the owner of the property to be disposed by Will;
- The property must be capable of being transferred; and,
- The property must he in existence at the time of testator's death, it is not necessary that it should be in existence at the time of making of Will.
- Any kind of property, movable or immovable, corporeal or incorporeal, may be the subject-matter of a Will.



Who All Can make Will:

Married Women: Before 1865 married Women were not capable of making will as they were governed by common law but after introduction of — Married Women property Act — A married woman may dispose may dispose by will of any property which could which she could alienate by her own act during her life.

Even after Hindu Succession Act 2005 Amendment – the woman have become coparceners which means they have share in the undivided property of family.

Deaf, Dumb and Blind: A blind person cannot be an Attestor but he is capable of making a Will of his property. Deaf and Dumb from birth is presumed to be an idiot that means he is incapable but this presumption can be rebutted if he is able to communicate his testamentary instructions by sign language and motions to an acquaintance who prepared will in conformity with instructions which was duly executed by executor- the court requires affidavit from the writer of the will

Mentally III and Insane Person: According to Law-Section 12 Indian Contract Act the person should be of sound mind and capable of understanding and forming a rational judgment to its effect.

- If a person is a of sound mind makes a will and subsequently becomes insane the will is not revoked by subsequent insanity The Testator's age, disease and mental weakness are important question in determining the soundness of mind.
- Mental Illness excludes 'Mental Retardation(Defined as Section 2 of Person with disabilities Act- which is condition of arrested or incomplete development of mind- For Example there is a joint will by three person but one of them is unsound it would not render invalid the disposition of other persons.
- The will of eccentric man is not put on same footing as the will of lunatic.

Will make be revoked or altered:

A will can be revoked or altered by the maker at any time when he is competent to dispose of his property by will.

Execution of Unprivilidged Will:

Sign or put thumb impression in presence of two witnesses- who should attest and not necessary should be present at same time –

Non Registration of Will-

Registration of Will is optional but registration proves its authencity and shows that the particular will existed in the office of the registrar.

Registration of Will:

If one wants one's Will to be registered, one has to visit the sub-registrar's office along with witnesses. There are sub-registrars for various districts and one has to find out from the concerned office about the one who will help in registering it.

Safe custody of Will:


There is a provision for the safe custody of a Will as detailed in the Indian Registration Act, 1908. The sealed cover containing the Will and superscribed with the name of the testator or his agent may be deposited with any registrar for safe custody.

Revocation of a Will

One can make a Will as many times as one likes, but only the last Will, executed before the testator's death, is enforceable.

Difference between Will and Gift Deed:

- A Gift Deed is a document that allows the original property owner to voluntarily give away their property to a person, trust or a party as a gift withought any money consideration.
- Gift Deed comes into effect immediately ie. One can immediately transfer the property by way of gift during his lifetime.
- Whereas in case of Will, the Will becomes effective upon the death of testator. The Gift deed becomes invalid incase its not registered and it cannot be
 - cancelled / revoked withought the interference of Court.



Intestate: Death withought making a Will:

The property of intestate devolves upon wife or husband or upon those who are kindered of the deceased in the order as per the schedule chart of Hindu Succession Act.

Property Transferable by Gift made in contemplation of Death: A man may dispose by gift made in contemplation of death any movable property (for ex: watch, bond, bank note, bill of

exchange etc.) which he could dispose by will.



The talk was followed by a spate of questions from the members. The Vote of Thanks was proposed by Rtn PP Cmde Pami Bawa. A memento, on bealf of the club, was presented to the Guest Speaker by Rtn PP Pradip Mitra.
