NI KSHAY MITRA AND POLIO NID



Some dream of a world without disparity, a world where everyone has equal opportunities to live, survive, work, and lead a fulfilling life. Sadly, however, this remains a distant dream, with the chasm between the haves and the have-nots deepening, creating an unbalanced society. In this world, a few enjoy all the luxuries, benefits, education, healthcare, and other privileges, while a large portion of our society struggles with insecurities. Instances of the poor succumbing to diseases due to lack of medical assistance are all too common. The vicious circle of poverty is stifling humanity.

So the question arises: Are the goodness of life, security, and healthcare privileges only for the rich? Or can these downtrodden, vulnerable children of God—those known as the marginalized section of society—find a messiah to adopt them, someone who can wave a magical wand to eliminate their helplessness and restore hope?

Providing a few drops of elixir in this ocean of disparity was the initiative of **Ni Kshay Mitra** and **Polio NID**. Ni Kshay Mitra began with the donation of food packets to TB-affected families, in the presence of Hon. MP Naresh Mhaske. The initiative also included providing food packets (generously donated by Rtn. Suresh Dol) to 330 healthcare workers across three health posts/vaccination booths in Thane. A total of 2,734 babies received polio vaccines at these booths to secure their future.



WHY POLIO SUBNID IS STILL NEEDED IN INDIA WHEN THERE IS NO POLIO CASE SINCE 2011?

"India continues to hold 1 NID and 2 Sub National Immunization Days (NID) for polio every year to maintain population immunity against wild poliovirus and to sustain its polio free status AND also to prevent re-importation of polio from polio infected countries Pakistan and Afghanistan, which are not polio free and 8 countries where polio virus is in circulation.

As long as one child remains infected, children in all countries remain at risk of contracting polio.

SINCE 1 MAY 2024, IT IS MANDATORY for polio vaccination requirement for all travelers entering India. This includes individuals TRAVELING FROM polio-infected countries (Pak and Afghanistan) and also travelers from countries with circulating poliovirus (Cameroon, Nigeria, Malawi, Mozambique, Madagascar, Congo, Somalia, and Syria).

To provide additional protection, GoI has introduced injectable Inactivated Polio Vaccine in routine immunization program in India".- By Dr Lucky Kasat
