A club member makes a comment during a planning meeting for a community service project, saying, "We should focus on helping this poor community because they're the ones who really need our assistance. I'm proud our club's projects will help them." This comment raises several ethical concerns, including:

## 1. Reinforcing negative stereotypes

- **Perpetuates poverty as a fixed state**. It implies that poverty is a natural characteristic of a community, rather than a result of systemic issues and historical inequalities.
- **Dehumanizes the community.** It reduces the community to a single characteristic (poverty) and ignores the diversity of individuals, skills, talents, assets, and experiences within it.

## 2. Perpetuating the hero-victim narrative

- **Positions the club as superior.** It suggests that the club is in a position of power and authority, implying that the community is helpless and reliant on their assistance.
- **Reinforces dependency.** This narrative can create a cycle of dependency and reinforce the idea that the community is incapable of helping itself.

This perspective is well intended but may negatively impact the club's reputation, its relationships with the community, and the community it seeks to support.

Ethical dilemma: How would you respond to ensure the club avoids perpetuating harmful stereotypes without creating a hostile environment? What are the consequences of ignoring or tolerating such behaviour?
