Decoding Budget 2026: Insights by PP Shailesh Haribhakti, Rtn. Anil Harish and Rtn. Gautam Trivedi, Moderated by IPP Satyan Israni



IPP Satyan Israni:

Good afternoon, friends. We are again at that time of the year when everybody seems to have an opinion on the fiscal deficit, GDP and taxes, whether it is a chaiwala or the chairman. This year too, Budget 2026 is no different. There has been a cross-section of reactions. Critics have called it anti-people, directionless, a masterpiece of deception, garbage of lies, and a Kursi Bachao Budget. Supporters have called it futuristic, balanced, growth-oriented, and a roadmap to Viksit Bharat.

And how do we forget those iconic lines of Ramdas Athavale in 2019? They ring true even today. He said, "This budget is very important for the middle class, the Scheduled Castes, the Scheduled Tribes, the OBCs, and the farmers. It is a very good budget, the best budget. It is also a very good budget. It is also a challenge to Rahul Gandhi and his opponents, as it will help Modi win. All taxes have been waived. This budget is the best budget."

To come to a conclusion, whether it is the best budget, a good budget, or a garbage budget, we have a stellar panel with us to help make sense of it all. First up, we will have the Past

President of our Club and renowned chartered accountant, PP Shailesh Haribhakti. This erudite auditor will give us the big picture while leaving no fiscal stone unturned.

He will be followed by eminent property and tax lawyer, Rtn. Anil Harish. This legal eagle will decode the Budget and its fine print so cleverly that even the Finance Minister may take notes.

And finally, we will have our own financial wizard, Rtn. Gautam Trivedi, who will tell us the real story behind the biggest stock market crash on Budget Day, to one of the biggest comebacks today, and derive for us the options we have for the future.

PP Shailesh Haribhakti:

Thank you very much to our Rotary Club for having us, at least once a year, for this interaction. I also love the way you introduced everybody in two sentences. This should become the next best practice for Rotary.

Let me describe this Budget as India's quiet ascent. That is how I see it. It has switched from arithmetic to architecture, and over the next ten minutes, I will share why I believe

this is the case. This Budget is not about the markets, nor is it about the trade agreements we have reached. It is about a moment.

Moments in history are rarely announced; they are recognised much later, as we will do in hindsight, when patterns suddenly reveal themselves. I believe we are living through such a moment for India. These are not isolated events. We have had three phenomenal treaties, with the UK, the EU, and just yesterday, although details are still unclear, with the US. As one of my Rotarian friends pointed out, President Trump may change his mind tomorrow morning, so we should be cautious about how enthusiastic we become.

Let me share what I experienced at Davos this year. Davos showed me that the global attitude towards India has changed dramatically. In the past, we went to Davos seeking investment, partnerships, and relationships, looking to gain something. This year, Davos was a true validation of India's greatness. Some of the announcements made were phenomenal. One of them was Devendra Fadnavis stating that Mumbai will have clean air and clean water. He stood alongside N. Chandrasekaran of the Tata Group and announced a mega transformation of Mumbai once again, including Rs. 11 trillion worth of data centre investments.

These announcements made Davos sit up and take notice. India is no longer asking for anything. India is managing everything together. It is growing, it is digitising, it is decarbonising and it is doing so quietly and steadily.

Why do I believe this Budget is a blueprint? It had nothing immediate for taxpayers, which is why the general public switched off. The new tax law was already in place. GST had already been amended.

The rationalisation of how the Income Tax Department and GST Department would interact with us was already on the anvil.

This is a blueprint that has unleashed five major forces. I will cover them briefly.

The first force is corridors as the new national spine. Multiple corridors have been announced. This is how a great economy should function. Just as our body has arteries that carry blood throughout, economies need corridors. We will have high-speed rail connections, dedicated freight corridors, expanded inland waterways, twenty of them, tourism circuits, rare earth value chains, chemical parks, and biopharma parks.

This is corridor thinking. It is physical, sectoral, and digital. Corridors compress distance, reduce logistics costs where India is among the highest, and convert science into scalable production.

A major, largely unreported change is that PSUs will no longer depend on markets for borrowing. They will monetise reachable assets, convert them into REITs, and use that monetisation to finance the next level of growth. India will export not just goods, but velocity.

The second force is AI infrastructure and the new digital world. Budget 2026–27 quietly acknowledges a fundamental truth: intelligence is now a factor of production. Intelligence is being manufactured in gigafactories. This is what AI is doing.

Through this Budget, any data centre established anywhere in India will enjoy tax exemption for twenty-two years. One might ask whether this is a giveaway. This is the biggest insight of the Budget. All announcements are future-oriented. We have never earned a single rupee from a data centre that has not yet been built. Therefore, granting a twenty-

two-year exemption to future data centres costs us nothing today.

Every incentive in this Budget is rooted in the future, not as a giveaway for the present. AI infrastructure will deliver compute capacity. Imagine a Hyperion coming up in Khavda. Meta had to go to Louisiana to build a giga data centre; we can do it right here in Khavda, where there is sufficient power and water.

Trusted data centres, digital public infrastructure, integration of identity, consent, payments and governance, multilingual AI platforms, together these will form a sovereign AI ecosystem. For the first time, the Finance Minister's speech was simultaneously available in four Indian languages using Sarvam AI. It was an exceptional experience.

The word ecosystem has entered the vocabulary for the first time. It is not about individual companies or individuals, but about creating systems. In a world worried about data misuse, algorithmic opacity, and digital authoritarianism, India offers democratic, rule-based, population-scale digital systems that are the envy of the world. I say this with full authority. We are currently implementing three digital public infrastructure projects across the world.

The third force is a tax and customs system built on trust. Hardly anyone in the media has commented on the phenomenal change coming in customs administration. Rationalised TDS rates, decriminalisation of technical offences, proportionate penalties, extended return timelines, risk-based customs...

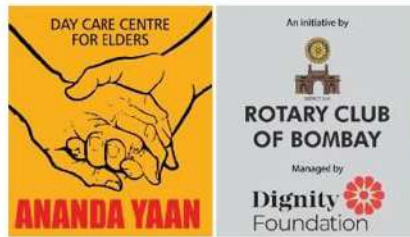

NEURODIVERGENT COMMITTEE HOSTS FREE EYE CAMP FOR CHILDREN

The Rotary Neurodivergent Committee organised a Free Eye Camp for neurodivergent children on January 29th, from 9:30 a.m. to 3:30 p.m., at Mankhurd, with a clear and compassionate objective: to strengthen early intervention through timely eye care.

The camp focused on identifying vision-related challenges that often go unnoticed in neurodivergent children, yet significantly affect learning, behaviour, and overall development. Many classroom difficulties stem not from lack of ability or effort, but from undiagnosed vision issues making early detection both impactful and life-changing.

A total of 34 children underwent detailed eye examinations during the camp. Free spectacles were provided to all children who required them, ensuring that financial constraints did not hinder access to essential care. Parents were counselled individually about their child's visual needs and were given written guidance for future reference. Several parents expressed heartfelt appreciation, sharing that the initiative offered both clarity and reassurance regarding their child's progress.

The medical services were led by Dr. Usha Johari, an eminent ophthalmologist and eye surgeon, supported by her dedicated team of optometrists and opticians. The spectacles were generously sponsored by Lawrence & Mayo, with Mr. Vivek Mendoza, Owner of Lawrence & Mayo, personally present to extend his support to the programme.

The camp was efficiently organised by Rtn. Ami Jagtiani, with special thanks to Co-Chair Rtn. Sunny Pariyaram for assistance with arrangements. The initiative was further strengthened by the presence and encouragement of President Elect Manish Reshamwala, Rotarians Siddharth Bhimrajka, Akhil Sanghi, Charu Agarwal, Anushka Jagtiani, Rtn. Ptn. Shobha Jagtiani, and Executive Secretary Rashmi Kotian, all of whom took time out to support the cause.

Visual impairments among neurodivergent children, particularly from low-income backgrounds, often remain undiagnosed, adding to existing developmental challenges. By addressing this fundamental yet critical need, the Rotary Neurodivergent Committee reinforced a powerful message: meaningful progress often begins with the ability to see the world more clearly.

The NMJ Municipal School organised a Science Exhibition for students of Standards 8 and 9 from G South Municipal Schools, with the aim of encouraging scientific thinking, creativity, and innovation. Several municipal schools from the G South area, including NM Joshi, G.K. Marg, Prabhadevi School, and Sitaram Mills School participated in the exhibition.

Students of Bhavishya Yaan (BY) from NMJ took part with great enthusiasm and confidence. The Standard 8 students presented projects on Environment and Waste Management by Trupti, Madhura, and Aarya; Transportation and Communication by Gargi, Gauri, and Vedanti; and Natural Farming by Vignesh, Soham, and Akshay.

The Standard 9 students showcased models on Types of Agriculture by Sneha, Vedant, Karan, and Varsha; Mathematical Modelling by Janavi, Chaitanya, and Parth; Disaster Management by Aastha, Rishabh, and Sakshi; and a creative Cube model by Shravani and Daksha.

Each student confidently explained the concepts, working principles, and scientific ideas behind their models. The exhibition provided a valuable platform for students to enhance their presentation skills, teamwork, and problem-solving abilities, while proudly demonstrating their scientific knowledge.

PENCILS INTO CIRCUITS: GK MARG AT NM JOSHI SCHOOL

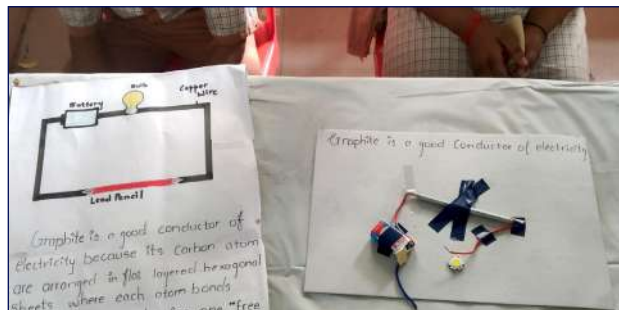
Students from G.K. Marg enthusiastically participated in the Science Exhibition held at NMJ Municipal School (BMC School), presenting an innovative project titled 'The Graphite Circuit in the Pencil.' The exhibit reflected curiosity-driven learning and a strong grasp of basic scientific principles.

Guided by their mentor, Priyansh Mishra, the 8th grade students explored the hidden electrical properties of everyday objects. Their experiment demonstrated that a simple pencil can act as a conductor of electricity. By using the graphite core to connect a small battery to an LED bulb, the

students successfully completed an electrical circuit.

When the LED illuminated, it clearly showed that graphite, a form of carbon, allows electricity to flow. The project challenged the common belief that only metals conduct electricity and highlighted the conductive potential of non-metallic materials.

The exhibit presented complex concepts in a simple, engaging, and visually effective manner, inspiring curiosity and hands-on scientific thinking among students and visitors alike.



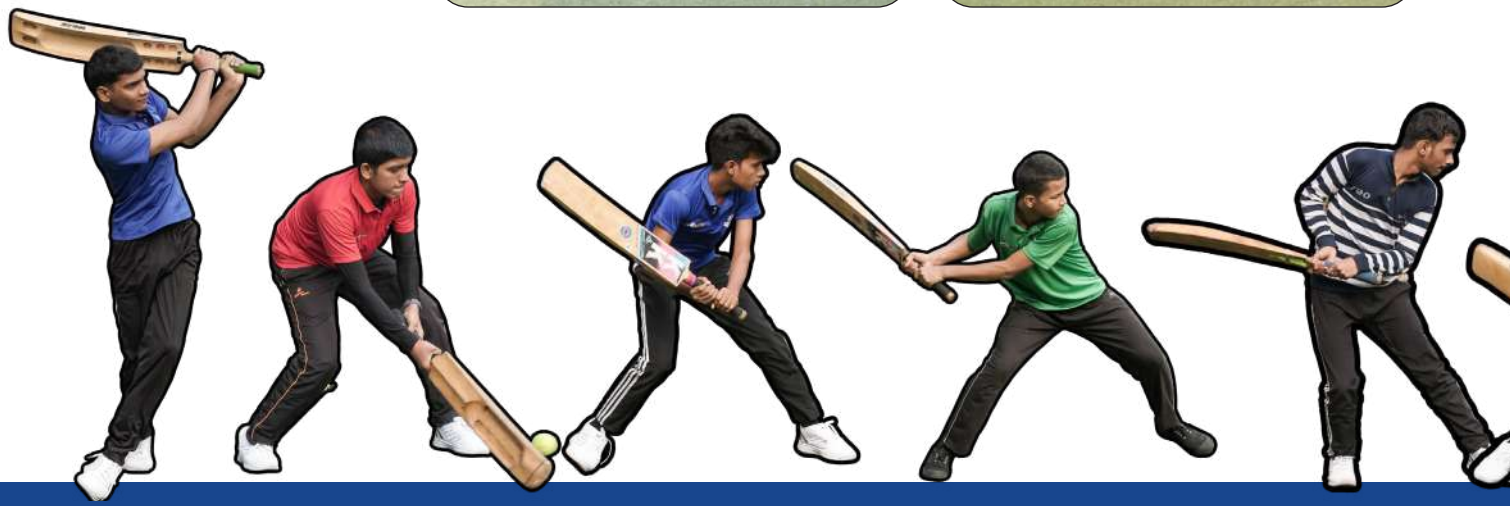
BY CELEBRATES ANNUAL SPORTS DAY AT NSCI

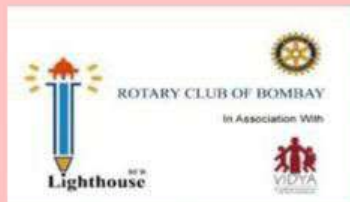

HISTORY & FOOD WALK IN BHULESHWAR

A group of 19 Mumbai enthusiasts came together for a delightful walk through South Mumbai, organised by the Heritage Art and Culture Committee of the Rotary Club, early on Sunday, February 1st. The journey began where the city itself began—at the Mumbadevi Temple, nestled in the bustling lanes of Bhuleshwar. The temple reminds us that Mumbai takes its very name from Goddess Mumbā, revered by the Koli fishermen, the city's earliest inhabitants, as their guardian deity. Amid the sounds of bells and prayers, it was easy to imagine traders and travellers from centuries past seeking blessings before stepping into uncertain futures. In true Mumbai style, a quick darshan revealed that Mumbadevi had moved here from her earlier establishment near today's CST Terminus and, as Bhuleshwar was a vegetarian neighbourhood, she too stopped accepting offerings of fish and wine.

Just outside, the irresistible aroma of sugar and ghee led the group to the legendary Mumbadevi Jalebiwala. Watching fresh jalebis spiral into hot oil and emerge glistening with syrup felt like a continuation of ritual—sweetness following faith, just as it has for generations.

The walk then moved through Kalbadevi to the serene Dwarkadhish Temple, dedicated to Lord Krishna. Built in the 19th century by Mulji Jetha's son and patronised by Gujarati devotees of the Bhatia community, the temple offered a moment of calm in a neighbourhood long shaped by commerce. The ritual of preparing the idol for darshan, including showing Him His reflection in a silver mirror, was a unique and fascinating sight, accompanied by paan prasad.

Food punctuated the journey at Shyamsundar Sweets, with seasonal Bengali delicacies such as singhada samosa and nolen gur rosogollas, followed by hearty Marwari flavours at

Rajasthan Kadhi Kachori. The group also passed Mumbai Panjrapole, one of the city's oldest gaushalas, established in 1834, standing as a testament to compassion amid urban chaos.

The walk concluded at Madhavbaug Laxminarayan Mandir, a spiritual anchor since 1785. A glass of fragrant Madhavbaug thandai brought the experience to a gentle close. With thanks to guide Riddhi Joshi and the committee's dedicated organisers Rtn. Robin Fernandes and Rotary Partner Khulood Noorani, under the guidance of Rtn. Anita Patel, the group dispersed with renewed appreciation for Mumbai's rich, resilient, and vibrant heritage.

MUMBADEVI TEMPLE

Our group of 19 Mumbai enthusiasts, on this fun walk through South Mumbai organised by the Heritage Art and Culture Committee of our Rotary Club early on Sunday Feb 1, began where it is best begun... where the city itself began—at the Mumbadevi Temple. Tucked into the bustling lanes of Bhuleshwar, the temple reminds us that Mumbai takes its very name from Goddess Mumbā.

The 'Koli' fishermen or the early inhabitants of Mumbai greatly respect and honor Goddess Mumbadevi, their guardian. Amid the sounds of bells and prayers, it's easy to imagine traders and travellers from centuries past seeking blessings before stepping into an uncertain future. In true Mumbai style, a quick darshan, learning that Mumbadevi moved here from her earlier establishment at modern day CSTerminus and since it was a vegetarian neighborhood, she too stopped accepting offerings of fish and wine.

JALEBI BABY!

Just outside, the scent of sugar and ghee leads to the legendary Mumbadevi Jalebiwala. Watching fresh jalebis spiral into hot oil and emerge glistening with



syrup feels like a continuation of ritual—sweetness following faith, exactly as it has for generations.

DWARKADHISH TEMPLE

From here, the walk moves through Kalbadevi to the Dwarkadhish Temple, a calm, devotional space dedicated to Lord Krishna. Built by Mulji Jetha's son and patronized by Gujarati devotees of the Bhatia Community in the 19th century, it offers a moment of stillness in a neighbourhood that has always thrived on commerce and community. The "Haveli" is the residence of Lord Krishna and there are specific darshan times throughout the day. The ritual of getting the idol ready and showing him his reflection in a silver mirror by the priest before the darshan was unique and interesting to observe, accompanied by a prasad of paan!

BENGALI SWEET & MARWARI SPICE

Food punctuated the journey at Shyamsundar Sweets, where seasonal Bengali treats like Singhada samosa and nolen gur rosogollas (soft & fragrant with date palm jaggery) mark fasting days and winter months. Nearby, Rajasthan Kadhi Kachori served hearty Marwari flavours, recalling the traders who brought their tastes—and traditions—to Mumbai. The kachoris were crisp, the kadhi was spicy and tangy, and everything was polished off by us all standing on the footpath. And a few greedy ones packed goodies for home.

MUMBAI PANJRAPOLE

We walked past narrow lanes and Panjrapole, one of the city's oldest gaushalas. Established in 1834, it stands as a testament to compassion amid urban chaos.

MADHAVBAUG LAXMINARAYAN MANDIR

The walk concluded in Madhavbaug, home to the Laxminarayan Mandir. This temple, since 1785, quietly watching Bombay turn to Mumbai. Dedicated to Lord Vishnu and Goddess Lakshmi, it has been a spiritual anchor for the area. Its gaushala reflects the area's tradition of seva and community responsibility. Supported by merchants and devotees, it was a way of giving back.

Finally, a glass of well spiced Madhavbaug thandai cooled the senses—rich, fragrant, and nostalgic—bringing the walk to a gentle, memorable close. With thanks to our guide, history and food enthusiast, Riddhi Joshi and to our committee's very detail oriented organizers Rtn Robin Fernandes and Rotary partner Khulood Noorani under the enthusiastic guidance of Rtn Anita Patel, we all went about our Sundays, in time for family lunches and gatherings.

Every walk in our city reminds us of the rich heritage of the melting pot our dear Mumbai is, the resilience of her people and the vibrant culture we have all imbibed and nurtured.



IT INNOVATION LAB- DAHANU WINNERS

Rohan Varma, a Class 7 student, showcased commendable innovation through his Robotics project under the Bhavishya Yaan Committee. His model, titled Ploughing Tractor, addressed a practical and relevant problem associated with traditional agricultural machinery.

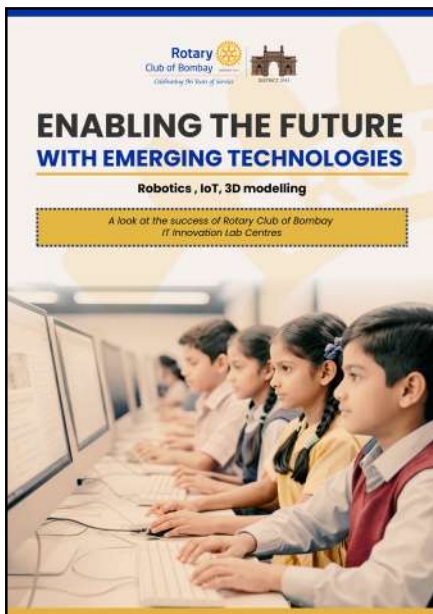
Rohan identified that conventional ploughing tractors are rigid in design, require large parking spaces, and pose safety concerns during road travel due to their size and limited manoeuvrability. To overcome these challenges, he proposed an improved tractor design featuring compact and foldable attachments to reduce

the overall length. He also introduced a shorter turning radius to enhance manoeuvrability and improve safety for both operators and other road users.

The final model demonstrated a clear grasp of mechanical principles, incorporating a pulley system for load movement and a gear mechanism to drive the tractor. This hands-on activity significantly enhanced Rohan's problem-solving abilities and self-confidence. He now appears more comfortable, engaged, and assured during classroom interactions, reflecting the positive impact of experiential learning in robotics.

Ronnie Screwvala is a first-generation Indian entrepreneur, philanthropist, author, and one of India's most influential business leaders. A pioneer at heart, he is widely credited with introducing cable television to India, persisting despite early setbacks when few believed in the idea. His entrepreneurial journey spans multiple industries, from building one of India's largest toothbrush manufacturing operations to launching ventures that were ahead of their time, including TV home shopping. Ronnie is best known as the founder of UTV, which, after years of



reinvention and resilience, grew into a leading media and entertainment company before being acquired by The Walt Disney Company in 2012. Recognised globally, he has been featured by Newsweek, Esquire, and Fortune for his influence and leadership.

A strong advocate of learning from failure, Ronnie is the author of Dream With Your Eyes Open and Skill It, Kill It. He is Co-Founder and Chairman of upGrad and Co-Founder of the Swades Foundation, dedicated to empowering rural India at scale.
