

#### Editorial...

Life isn't about what you have but what you have to give. If there's one thing everyone on the planet wants to do, it's to be happy. As it turns out, giving is an excellent way to achieve this. Life becomes really fulfilling and happy when we give and share, and that great inner joy comes from helping others to better their lives. Giving provides an intrinsic reward that is far more valuable than the gift we receive. As Mahatma Gandhi once said: "The best way to find yourself is to lose yourself in the service of others." True joy lies in the act of giving without an expectation of receiving something in return. The act of giving kindles self-esteem and brings happiness.

Too often we underestimate the power of a touch, a smile, a kind word, a listening ear, an honest compliment, or the smallest act of caring, all of which have the potential to turn a life around.

The joy of giving lasts longer than the joy of getting. Due to hedonic adaptation, the happiness we feel after a particular event or activity diminishes each time we experience that event. But giving to others is an exception to this hedonic adaptation rule. Happiness doesn't decline if they repeatedly bestowed gifts on others versus repeatedly receiving those same gifts themselves.

The most important thing behind our giving and receiving is the intention behind it. When the act of giving is joyful, when it is unconditional and from the heart, then the energy behind giving increases many times over. But if we give grudgingly, there is no energy behind that giving. If we feel we have lost something through the act of giving, then the gift is not truly given and will not cause an increase in happiness quotient. The gifts of caring, attention, affection, appreciation, and love are some of the most precious gifts we can give, and they don't cost anything except our intention and attitude. Time, help, and support are three excellent ways to give that don't cost even a single penny. These, too, have drastic beneficial effect on our health and happiness.

The Law of Giving and Receiving is simple: If we want love, we have to learn giving love, if we want attention and appreciation, we have to learn to giving attention and appreciation, if we want material affluence, we have to help others to become materially affluent. If we want to be blessed with all the good things in life, then we also have to learn to silently bless everyone with all the good things in life. The more we give, the more we will receive. In our willingness to give, we will keep the abundance of the universe circulating in our life. Even the thought of giving, the thought of blessing, or a simple prayer has the power to affect others.

If you ask people why they give, the readiest answers offer clues to the mystery. 'God wants me to.' 'I feel better about myself.' 'Others need, and I have.' 'I want to share.' 'It is only right.' A hazy halo encircles these good-hearted answers, and if we bring it into focus, the following seems true: Giving takes you out of yourself. You expand beyond your limitations. When giving results in an experience of love, joy, peace, charity, caring, and self-worth, then the process of expansion starts. You get a glimpse of ecstasy. The mystery of giving is revealed only when you crave the ecstasy that has been glimpsed. You open a conduit for the kind of happiness that no one can ever steal from you.

So, we, as the Rotarians, must first imbibe the value of giving, and then make people understand about it. This is the only way we can build a better society for ourselves.

## Stephanie A. Urchick

R.I. President: 2024-25

Stephanie A. Urchick, of the Rotary Club of McMurray, Pennsylvania, USA, is the selection of the Nominating Committee for President of Rotary International for 2024-25, a decision that would make her only the second woman to hold that position.

She will be declared the president-nominee on 15 September if no challenging candidates have been suggested.

With the world facing incredible challenges, including the COVID-19 pandemic, disasters driven by climate change, and conflict in many regions, Urchick says Rotary's leaders can offer a vision and a plan for overcoming these challenges.

"Measures taken by Rotary leadership to survive and end critical challenges often make our organization stronger and more resilient for future events," Urchick says. "This kind of essential leadership also creates new levels of cooperation, even among rivals, when Rotarians pull together as people of action to serve and solve a crisis."

Making regionalization a priority is crucial, says Urchick. "Because Rotary operates in more than 200 countries and regions, it is vital to recognize that the organization has the potential to become more efficient and effective by understanding and reacting to how regional differences affect the way Rotarians work together to address providing service, promoting integrity, and advancing world understanding, goodwill, & peace,"

Urchick is a partner and chief operating officer of Doctors at Work LLC, a consulting and training company. She holds a doctorate in leadership studies from Indiana University of Pennsylvania. She is active on numerous community boards and committees and has been honored by organizations including Zonta International and the Sons of the American Revolution.

A Rotary member since 1991, Urchick has traveled to Vietnam to help build a primary school and to the Dominican Republic to install water filters. She studies several Slavic languages, has mentored new Rotarians in Ukraine, and coordinated a Rotary Foundation grant project in Poland.

Urchick has served Rotary in many roles, including as a director, Foundation trustee, and chair of the RI Strategic Planning Committee and the Foundation's Centennial Celebration Committee. She currently serves on the Election Review Committee and the Operations Review Committee. She is a Rotary Foundation Major Donor and a member of the Bequest Society.

Membership provides continued support for the many programs of The Rotary Foundation. Membership is our primary resource and what builds and maintains strong and healthy clubs.

The three elements of membership growth are:

- ▶ The retention of existing members
- ▶ The proposal of new members
- ▶ The organization of new clubs

These three elements are equally important, each element is essential to overall membership efforts and needs to be emphasized at both the club and district level.

#### Considerations for Retention

- How informative and lively are your club's weekly programs?
- Are your weekly club meetings held in a comfortable and attractive venue?
- How relevant is your club to its members' interests and the community?
- How relevant and effective are your club service projects to the community?
- Does your club respect its members' time and keep to its meeting schedule?
- Does your club personally contact members who miss meetings?
- Is your community aware of your club and its accomplishments?
- How connected are your members to the club and to one another?
- Do your members have adequate opportunities to get to know one another?
- Are your members aware of their responsibilities to the club and to Rotary International?
- How active are your members on service projects, committees, and club operations?
- How informed are your members of Rotary's work at the community, district, and international levels?
- How effectively and frequently do you communicate to your club members?
- Are you aware of why members are leaving your club?
- Do your members make efforts to include new members in all activities?
- Does your club have ongoing new-member orientation and continuing education programs?







#### **Considerations for Proposing New Members**

- Are the business and professional interests of your community adequately represented in your club?
- Do you conduct a classification survey annually?
- Is your community aware of your club and its accomplishments?
- Do your members appreciate the importance of membership for supporting the goals of The Rotary Foundation?
- Is your community aware of opportunities for global friendships and service through RI and Foundation programs?
- Are your members communicating the efforts of your club to their friends and business associates?
- Do your members feel comfortable about bringing guests to club meetings?
- Are your weekly club meetings held in a comfortable and attractive venue?
- Are your members open to bringing in new members?
- Does your club have an ongoing and effective new-member induction program and ceremony?
- How effectively do you communicate your club's programs and projects to prospective members?
- How attractive and effective are the materials and tools you distribute to prospective members?
- If you were a prospective member, would you be interested in joining your club?
- Does your club adequately represent the diversity of the population?

#### **Considerations for Organizing New Clubs**

- Is there a community that could support a Rotary club that is not represented by Rotary?
- Are there enough clubs in the community to represent the total population?
- Are there clubs in a community to accommodate varying schedules?
- Do you have strong support for a new club and enough charter members?
- Do you have a strong sponsoring club for a new club?
- Is there adequate financial and administrative support for a new club?
- Will the charter members have the ability and capacity to effectively operate a new club?

These are just a few suggestions and ideas to consider in reviewing and planning for the club or district membership growth and development program during the year.

#### **Essential Practices for All Clubs**

As a second-generation Rotarian with over 35 years of experience since Rotaract and a past district leadership role, I'd like to share some insights to help make your club vibrant, engage members effectively, and enhance the overall quality of membership. Here are a few key ideas to consider:

**Installation Ceremony, Charter Day Celebration, and DG Official Club Visit (OCV)** Regardless of your club's size or age, these events should be celebrated enthusiastically. Include Rotarians, their families, prospective members, beneficiaries, stakeholders, and project partners. If budget constraints make a dinner event challenging, consider hosting these events from 4:00 to 6:00 PM with evening snacks.

Fellowship Meetings Fellowship doesn't have to involve alcohol. Meetings can be held over breakfast, lunch, evening snacks, or dinner, depending on your club's affordability. Changing venues can attract more Rotarians and their families. Consider potluck dinners or holding meetings at various food joints. Each club should aim for a minimum of six family fellowship meetings and six Rotarian fellowship meetings annually. Additionally, plan for 4 to 6 Club Assemblies and Board Meetings. If possible, board members can host these meetings at their homes or offices based on their comfort and affordability.

Communication Teams Establish a minimum of 6 or 12 communication teams, depending on the club's size. Each team should have a leader, preferably someone who hasn't been a club president. Assign months to each team from July to January (or two months if there are six teams). During their assigned months, teams will manage communication, collect dues, and organize fellowship dinners.

The President/Secretary will share all communications with the team leaders, who will then disseminate information to their respective teams. Team leaders and members should be recognized for timely and complete collections. These activities will foster leadership skills among members.

**Birthday and Anniversary Wishes** Implement a consistent practice of wishing members on their birthdays and anniversaries. This should go beyond WhatsApp messages to include personal phone calls. The president, along with an assigned team leader or member, should visit members' homes to deliver customized cards and a small gift like chocolate or cake. The President-Elect must also be assigned to wish members on their birthdays with the help of an assigned team leader and member. This personal touch will strengthen the sense of family within the club.

By this President saves time for visiting both the occasion and the President-Elect gets connected with members for the succeeding year.

Club Magazine/Bulletin Publish at least one club magazine annually, ideally during the club installation ceremony, and if possible, also for the charter day and DG OCV. If budget constraints exist, a digital version is a good alternative. Share the club magazine officially by email with the district office, DG, and other clubs through various media channels.

Club Documents Rotary believes in rotation and the creation of new leaders every year. To ensure a smooth transition, it is essential to meticulously record and maintain documents related to our achievements, stakeholders, membership strength, accounts, completed service projects, and club inventory. These records serve as valuable references for incoming leaders, including the president, secretary, treasurer, and committee chairs.

Proper documentation helps new leaders build on the previous year's successes and ensures continuity in our initiatives. For detailed information on the essential documents a club must maintain, I have already shared guidelines with most of the club leaders. If you need further details, please feel free to reach out.

**Each Member, One Meeting/Assignment Per Year** In an active and large club, more than 50-100 activities occur annually, including meetings, projects, and programs. Each member should be assigned to lead at least one meeting or program per Rotary year. For this assignment, the member will organize the venue, invite members and their families (if applicable), arrange the stage, and serve as the master of ceremonies. They will set up the meeting table with the collar, gavel, and other necessary documents as per the club checklist. The member may also speak on a Rotary-related topic, share their expertise on a non-Rotary subject, or read news from the current Rotary News magazine. This opportunity allows the members to serve the club, enhances their leadership skills, and fosters communication with other members during the invitation process.

Felicitation of Rotarians' Parents During Dinner or Speaker Meetings To honour the parents of our members, we can adopt a process of felicitating them with a Rotary scarf and a written recognition during dinner or speaker meetings. We can create a list and, as availability allows, invite members' parents to these meetings for their felicitation. This gesture will allow parents to learn more about Rotary, making them proud that their sons or daughters are part of an international, century-old organization dedicated to serving society through various permanent projects. Recognising parents in this manner will make them feel privileged and can also encourage regular absentee members to attend meetings.

**Enhancing Club Image During Meetings** During club meetings, especially public ones, it is essential to have clear and professional displays that enhance the club's image and motivate both members and non-Rotarians, which include the following key elements

Club Banner: Display a neat and unobstructed banner on the stage, ensuring it does not hinder any creative elements of the meeting setup.

Welcome Banner: Always have a welcoming banner to greet attendees.

Four-Way Test Banner: Display the Four-Way Test banner prominently.

Recognition Banners: Include banners listing AKS, Major Donors, and PHF contributors to TRF to encourage other members.

Achievements and Projects: Highlight major club achievements and provide information on ongoing permanent projects. This should include details on how members and their families can volunteer and contribute.

Inspirational Displays: Include any other relevant displays that enhance the club's image, inspire and motivate members, and attract non-Rotarians to become members.

Classification Survey Conducting a classification survey of both your club members and the available classifications in your locality is crucial. An up-to-date member classification survey reflects your club's strengths. Equally important is identifying classifications present in your locality but not yet represented in your club. This information, including names and addresses, helps club leaders and the membership chair to invite potential new members.







For example, if your club lacks members from essential sectors like LPG dealers or petrol pump dealers, which are common in every locality, you can extend invitations to them for membership.

It's recommended to hold special meetings focused on classification surveys at least twice a year. During these meetings, every member should bring potential names and classifications they know. Compile this information and, on a significant day such as your club's charter day or Rotary Day, invite a District leader to speak about Rotary's history and achievements in your District, India, and the world. This will attract and inspire invitees to become new member.

**New Membership Policy** Adopting a membership policy in every club is crucial. Never induct a member unless their name is uploaded on rotary.org. Restrict bulk inductions during events like OCV, Charter Day, or any other significant event unless they are already members.

Invite potential members to volunteer in your service projects and attend fellowship dinners and speaker meetings. Clearly explain their financial obligations, TRF contributions, and the costs associated with attending various district events. Aim to secure at least a two-year subscription initially.

After a prospective member has attended 3-4 service projects and fellowship meetings over 4 to 6 months, and if they agree and most club members are in favour, only then should you induct them. Inducting a member without their consent, without explaining financial obligations, or without collecting the subscription can become a liability for the club, as the club will be responsible for paying their dues to both the district and RI, which amounts to approximately Rs. 9,000.00.

Attending District and International Events Every year, more than 10 to 12 district events are organized, including Pre-PETS, PETS/SETS, the District Learning Assembly, DG Installation, Membership Seminar, Foundation Seminar, Public Image Seminar, DEI Seminar, District Conference, Award Ceremonies, and many more. Additionally, 4-6 international events are held, such as the Presidential Conference, International Peace Seminar, and International Conventions.

While it may not be feasible for all leaders or members to attend every event, it is beneficial for members to participate in as many district events as possible. Doing so helps them connect with more Rotarians and enhances their Rotary experience. According to members' affordability, the club should strive to be visible at each district event.

Having attended the recent International Convention in Singapore, I can attest to its value. If members can afford it, they should attend these international events, as they are incredibly interesting, informative, and provide a deeper understanding of Rotary.

To encourage participation, the club should maintain a register of all members attending various events and recognize those who attend the most events at the end of the year. Special recognition should be given to members attending international conventions and presidential seminars.

Conclusion There are many more ideas to explore. I have not delved into sustainable, measurable, and need-based projects tailored to your local community, as Rotary plans globally and implements locally. In the future, I will share more insights regarding projects, programs, events, and Rotary movements, as well as strategies for enhancing our public image and sharing our Rotary stories with both Rotarians and non-Rotarians. Additionally, I will guide how to effectively collect contributions for The Rotary Foundation (TRF) from those who have paid in the past but not recently, new donors, and even family members and relatives of current members who are not yet Rotarians. Your individual experiences and innovative ideas are welcome and can be shared with the rest of the Rotary community.

By incorporating these practices, your club can become more vibrant, engaging, and recognized as one of the best in the district.
