Minutes of the 9th Board of Directors Meeting.

Date: 25th March 2026

Venue : Cuttack Club Annexe-1

The Meeting was called to order by President Rtn Sujata Priyadarshini.

The minutes of the eighth board meeting were presented and confirmed.

The Board reviewed the Income & Expenditure statement.

It came to the notice that a sum of ₹.2,75,000/- was shown as received from liquidation of five fixed deposits. The treasurer informed that as there was extra expenditure due to rise in dollar rate, extra sum of ₹.50,000/- had to be paid towards RI dues. Another sum of ₹.60,000/- had to be paid to the caterer towards food charges for Eighty-year celebration. On query, the treasurer could not explain such extra payment towards RI dues as the income expenditure statement reflected ₹.13,000/- extra payment towards RI dues due to dollar hike. The treasurer was requested to enlighten the members regarding the same in the next Board meeting. It was also unanimously decided to place the minutes of the special Board meeting called for the purpose of liquidating the FDs before the general body for approval. This was suggested by PP Rtn. Prabhat Kumar Misra & PP. Rtn. Devashis Panda.

It was decided to ask the members to pay the differential amount paid towards dollar hike. Since some members had not paid their dues, the President was authorised to drop those members if they fail to clear their Club dues by the end of May in spite of persuasion.


It was decided that a sum of ₹.1,65,000/- to be invested in a fixed deposit which was the residual amount from the Fixed Deposits that were liquidated to make RI payment and clear the caterers bill.

Plan for next month was finalized after due deliberation.

Rtn. Mahesh Patel volunteered to host next joint board meeting to be held on 24.04.2026.

There was thread bare discussion on OCV (Official Club Visit)

Request of one Sampurna Baral to do Internship in our Club and our permanent projects for one year was approved. Vote of thanks was proposed by PP Rtn. Bijoy Dasmohapatra where after the meeting was adjourned by President Rtn. Sujata Priyadarshini.
