Rotary year 2024-25 started with the President seeking blessings at Shri Nadha Sahib Gurudwara on 1st July 2024 along with DG Rajpal Singh followed by Presidents' collar ceremony at Mata Mansa Devi Temple Panchkula by DG.

Inaugural event of Project Maa was launched on 01st July 2024 at General Hospital Sector-6, Panchkula by distribution of homemade Panjiri stuffed with nutrients and medicines essential for new mothers. Newborn babies were also provided clothes. The second event was completed on 23rd of the month. Subsequent events will be on 23rd of each month, aggregating to 13 events during the year.

The Doctors Day was celebrated at General Hospital, Sec 6, Panchkula wherein 4 doctors were honored with Mementos for their outstanding contribution to the society.

Egg bank Project, which is an existing Project, was relaunched with new branding on 05.07.2024. The full year supply of required eggs was committed to Pediatric ward and TB ward patients. The monthly supply date will be 23rd of each month.

Annapurna day was celebrated on 07.07.2024 by distribution of Langar, which was sponsored by Rtn Anurag Jain, celebrating the birthday of his son's.

Project School fee was completed by depositing the yearly school fee, amounting to Rs 67000/-, for 2 children namely Ayansh Verma and Arnav Verma, by the club.

Project umbrella was completed on 14.07.2024 by distribution of 25 umbrellas to street vendors such as shoe maker, tea vendor and fruit vegetable sellers in various sectors of Panchkula so as to enable the vendors to protect them from sun and rain.

Under Project RVTC a group of Annes led by 1st lady Mrs. Asha Mittalvisited RVTC on 15 July 2024 and organised a quiz competition for RVTC students. The students were provided nutritious meal with snacks.










KNOW YOUR PRESIDENT
