
# **Navigating Nominations and Wills: Safeguarding Your Legacy**

n Monday, 17th March 2025, members of the Rotary Club Chandigarh and Rotary Club Chandigarh Uptown gathered for a joint meeting, featuring an insightful session on estate planning and wealth management. Rtn.Awinash Taneja introduced the guest speaker Mr.Rupender Kumari The guest speaker for the evening, Mr. Rupender Kumari, Ex-Regional Manager of SBJ Industry and an expert in wealth management, delivered a compelling talk on the importance of nominations and wills. The discussion kicked off with a thought-provoking question: How many people have written a will? This simple query underscored a common oversight-many individuals,

despite having significant assets, fail to draft a formal will, leaving their legacy vulnerable to disputes and legal complications. Key Takeaways on Will Writing Mr. Kumari shared essential points to consider when drafting a will, emphasising the importance of clarity and legal compliance: -

- 1. Personal Identification: The will should begin with an introduction of the testator (the person writing the will), along with their Aadhaar Card number.
- 2. Mental Soundness: In India, a valid will can only be written by a person who is of sound mind and at least 18 years old.
- 3. Free Will: The document must be written voluntarily, without any external pressure or coercion.





- 4. Detailed Asset Listing: Clearly list all properties, financial assets (bank accounts, investments), and personal belongings, specifying full addresses and details.
- 5. Beneficiary Identification: Each beneficiary should be named with their full name and address to prevent ambiguity.
- 6. Exclusion of Heirs: If certain heirs are not to receive

a portion of the estate, their names should be explicitly mentioned along with the reason.

## **Navigating Nominations and Wills...**

- 7. Precise Asset Distribution: Clearly state the portion of each asset assigned to beneficiaries to avoid disputes.
- 8. Heirs' Non-Involvement: Beneficiaries should not participate in the writing process, ensuring the will remains legally unchallengeable.
- 9. Appointment of an Executor: A trustworthy executor should be designated to oversee the execution of the will as per the testator's wishes.
- 10. Legal Adherence: The will should comply with the Indian Succession Act, 1925.
- 11. Signature and Witnesses: The will must be signed by the testator (matching the signature on their Aadhaar or PAN card) and attested by at least two independent witnesses who are not beneficiaries.
- 12. Will Registration: While not mandatory, registering the will can serve as conclusive proof of its authenticity and execution. Understanding Probate and Succession The session also covered crucial legal processes



related to wills:-

- Probate: After a person's passing, the executor can apply for probate, a court-supervised process to validate the will and ensure its execution.
- Succession: This refers to the legal process of distributing the deceased person's assets, especially bank savings, as per the instructions outlined in a valid will.
- Comprehensive Asset Listing in a Will To ensure an effective will, a detailed listing of assets is crucial:-
- Property: Include full addresses, names of joint owners, and area specifications.
- Financial Assets: Provide account numbers and the value of assets at the time of writing.



• Personal Belongings: List valuables such as jewelry, paintings, and other collectibles, along with their location.

• Future Assets: A will can include

a clause to cover assets acquired or

inherited after its drafting. Mr. Kumari also highlighted that if an individual intends to distribute assets equally among heirs, there may be no need to draft a will. However, it is advisable to update the will periodically, especially when major life circumstances change. A Thought-Provoking Discussion The session concluded with an engaging Q&A session, where members raised pertinent queries on legal intricacies, asset protection, and inheritance planning. The discussion provided invaluable insights into the significance of will-writing in
