BUSINESS MEETING

Arun Aggarwal. The quorum of the meeting as per bylaws of the club was complete and after the regular announcements, the items as per agenda of the meeting were taken as under:-




Obituary

Grants available for projects

The Rotary Foundation offers grants that support humanitarian projects, scholarships, and vocational training teams.

Global Grants

Global grants fund large international humanitarian projects, scholarships, and vocational training teams that have sustainable and measurable results in one or more of Rotary's areas of focus. The application asks about your grant's objectives, participants, sustainability, budget, and financing. Make sure that the grant falls within Rotary's global grant guidelines, is technically feasible, your and your partner club are qualified to address this need, and issues aren't already being addressed by another organization.

District Grants

District grants fund smaller-scale, short-term projects that address immediate needs in your community or abroad. Each district chooses the activities it will fund. Districts may apply up to 50 percent of their District Designated Funds to a district grant each year. Grant applications need to be authorized by the district governor, District Rotary Foundation committee chair, and district grants subcommittee

chair and submitted to the Foundation for approval. Clubs work directly with their district to get funding. Your district governor or Rotary Foundation chair should be able to tell you when to submit a request and whether you'll need to meet additional district requirements.

Disaster Response Grants

Disaster response grants support disaster relief and recovery efforts through grants from the Rotary Disaster Response Fund. Districts that have been affected by natural disasters can use Rotary disaster response grants to launch their own projects or work with established relief organizations to help their communities recover. Once qualified for Rotary grants, districts in an affected are a or country may apply for a maximum grant of\$25,000, based on the availability of funds. A district may apply for subsequent grants after it successfully reports out comes from previous grants. The district governor and district Rotary Foundations chair can apply.

Programs of Scale Grants

Programs of scale grants support Rotary member-led, evidence-based programs that have already demonstrated success. Scaling proven programs will benefit more people and foster policy development and sustainable programs. Each year, Programs of Scale will support a competitive grant process resulting one award of US\$2 million from The Rotary Foundation that is distributed over a three- to five-year period to a club- or district-sponsored program showing success and readiness to expand to help more people in more places. While the programs must be sponsored by a qualified club or district, the programs will be implemented with experienced partners who are also committed to long term success and sustainability.

Rotary Healthy Communities Challenge

Rotary Healthy Communities Challenge is an invitation-onlyprogram for target countries that provides longertermresources to implement large-scale, high-impact programs to reduce severe disease and death from malaria, lower respiratory infections, and diarrhea — the top killers of children under 5 years. The program focuses on vulnerable populations and improving accessibility and quality of sustainable community health systems. For the first Rotary Healthy Communities Challenge, the countries invited to participate are Nigeria, Zambia, Democratic Republic of Congo, and Mozambique. Each country submits one country-level application.
