

A super collective involvement of all members, help in driving project resulted with a 7 projects in a day (26/10/24) across various part of the city.

Am personally very proud to see 101 projects getting completed in 123 days and this would not have been possible but for the passion and efforts of Neokars.

# RCMN SUPPORTS WORLD RECORD SETTING VISUALLY IMPAIRED CYCLISTS

#### Welcome. Neo-kars!

Rotary Club of Mumbai Neo is proud to be associated with a world record breaking cycling expedition. Named 'Race Across India, Race for Vision', it was a remarkable feat of resilience and determination. A team of visually impaired cyclists has made history by completing a journey from Kashmir to Kanyakumari. Covering nearly 3,758 kilometers across 12 states of India, this extraordinary group of cyclists, supported by sighted pilots on tandem bicycles, embarked on this ambitious expedition to raise awareness about disability inclusion and break barriers around physical limitations.

The journey, which began from Kashmir on October 10 and ended at Kanyakumari on October 19, saw the team pedaling through diverse terrains and weather conditions, from the mountainous regions of Kashmir to the flat plains and tropical climates of southern India. What makes this achievement even more

inspiring is that the cyclists not only covered this vast distance but also set a new world record for the longest tandem bicycle journey by a team of visually impaired riders.

This historic expedition supported by RCMN was led by Santosh Sansare – an honorary member of RCMN. Sridhar, Arun and Anand from our Club donated a tandem cycle for the expedition. RCMN sponsored two visually impaired cyclists – Sagar Vasant Bodke and Ajay Lalwani – both from Nashik. The expedition proved that disabilities are not limitations but challenges that can be overcome with perseverance and the right support.

Throughout the journey, the cyclists faced a series of challenges, from rough roads to fluctuating weather conditions. However, their determination and teamwork kept them going. The sighted pilots on each tandem cycle navigated the route while the visually impaired riders pedaled with equal strength and enthusiasm, demonstrating the power of collaboration and trust.

The cyclists made stops along the way to spread the message of inclusivity and the need for better opportunities for people with disabilities in sports and beyond. At each stop, they were greeted by cheering crowds, local dignitaries, and supporters, further energizing their mission. The Rotary spirit and signage were visible throughout the expedition.

By achieving this world record, these visually impaired cyclists have set an inspiring example for all, showing that physical limitations do not define one's capabilities. They have redefined the limits of possibility, opening doors for future athletes and adventurers with disabilities. The participants, including defense personnel and doctors, showcased the diversity and unity of the team. The spirit of Rotary was underlined all the way.

## NAVIGATING GLOBAL AI REGULATIONS IN 2024: KEY DEVELOPMENTS AND FUTURE DIRECTIONS

In recent years, governments worldwide have actively pursued regulatory frameworks for artificial intelligence (AI), particularly for generative AI, to address ethical concerns and establish a balance potential to influence society and the need to manage its risks effectively.

Lawsuits against major AI companies like OpenAI have underscored the critical need for clear guardrails in the use of vast datasets, especially as large language models (LLMs) continue to rely on extensive and sometimes copyrighted content for training. These legal actions highlight the urgency of regulatory measures to protect intellectual property and ensure ethical AI usage.

## Notable Cases against AI Companies using Large Language Model:

- Getty Images vs. Stability AI Getty Images filed a lawsuit against Stability AI, alleging unauthorized use of over 12 million images to train its AI model, Stable Diffusion, a popular text-to-image generator.
- Authors Guild vs. OpenAI In a class-action suit, the Authors Guild and several authors, including notable novelists, sued OpenAI for using their copyrighted works to train ChatGPT without permission.

- Thomson Reuters vs. ROSS Intelligence Thomson Reuters sued ROSS Intelligence,
  alleging that the company used Westlaw's
  proprietary legal data to train its AI-based
  legal research tool without authorization.
- Copilot (GitHub and OpenAI) and the Software Developers' Lawsuit - GitHub Copilot, an AI code generator trained on publicly available code from GitHub, faced a class-action lawsuit from software developers who alleged that their code was used without consent.

In response to these rising concerns, countries are implementing more rigorous policies and protocols around AI.

#### Global AI Regulations and Guardrails

Europe leads the AI regulatory front with its comprehensive AI Act, a pioneering regulation that uses a risk-based approach to categorize AI systems based on potential societal impact. High-risk AI applications face stringent requirements, including data privacy, algorithmic accountability, transparency, and ethical guidelines. The framework mandates emergency shutdown mechanisms for high-risk systems to safeguard users, emphasizes auditing for compliance, and promotes cross-border cooperation to ensure consistent enforcement across EU member states.

The United States has several regulatory bodies, including the National Institute of Standards and Technology (NIST) and the Federal Trade Commission (FTC), actively contributing to ethical AI development. NIST's AI Risk Management Framework (RMF), though non-binding, is an industry-agnostic guide addressing risk mitigation in AI. It promotes trustworthiness through principles like fairness, accountability, and resilience. With the

rise of sector-specific initiatives, the U.S. regulatory landscape is evolving to manage data protection, copyright issues, and cybersecurity risks associated with AI systems.

In **Asia**, countries like **Japan** have developed policies centered around "human-centric AI" under their **Society 5.0** initiative. The Japanese government enforces guidelines for transpar-

ency, data protection, and fairness, though these are not legally binding.

**China,** a significant player in AI, has introduced ethical guidelines and drafted specific AI-related laws targeting deepfake regulation, while **South Korea** emphasizes transparency and ethical AI use through its AI Ethics Committee.

#### **Future Plans and Recommendations**

Despite these efforts, AI regulation remains in its nascent stages, requiring global collaboration and continuous evolution to stay effective. The European Union is working to expand its regulatory reach, intending to set global standards for ethical AI practices. The U.S. aims to make NIST's framework a global benchmark, focusing on AI trustworthiness, safety, and fairness.

India is emerging as a unique case in AI regulation, focusing on generative AI for sectors like agriculture to bridge digital divides. With initiatives like KissanGPT, India leverages AI to enhance rural productivity, underscoring the need for tailored frameworks that consider socioeconomic diversity.

A four-phase roadmap is proposed, combining regulation, education, stakeholder involvement, and a supervisory authority to monitor AI implementation and ensure responsible AI development.

#### **Recommendations for Robust Al Governance**

- 1. Enhanced Transparency and Data Privacy:
  Regulators should mandate that AI systems explain their decision-making processes, allowing users to understand AI-generated outcomes. Compliance with data privacy standards, similar to GDPR, must be enforced to protect user data and mitigate privacy violations.
- Promoting Algorithmic Fairness: Al systems
  often reflect the biases present in their
  training data, impacting fairness.
  Governments should incentivize the development of fairness-enhancing algorithms
  and require audits to ensure algorithms are
  free from biases, enhancing trust in Al
  outcomes.
- 3. Content Moderation and Intellectual Property:
  Intellectual property laws should address
  the ownership and copyright of AIgenerated content, emphasizing transparency and proper attribution. Content moderation practices must be standardized to
  prevent the spread of harmful content and
  misinformation.



- 4. Collaborative Global Standards: Establishing global standards for AI ethics can harmonize disparate regulations, fostering international cooperation and reducing regulatory complexities for companies operating across borders. Nations should consider collaborative frameworks for ethical AI governance and share best practices to streamline AI policy implementation.
- 5. Stakeholder Engagement and Education:
  Effective AI regulation requires a balanced approach that involves government, corporations, and the public. Corporations should implement ethical AI practices and invest in transparency, while public awareness campaigns can educate users about AI rights and safety.
- 6. Flexible and Evolving Regulations: As AI technologies evolve, regulations must adapt. Governments should establish adaptive regulatory mechanisms that can respond to new developments, ensuring AI policies remain relevant and effective.



We often compare Indian streets with public spaces abroad and wonder why we are so backward. But as is said 'beauty is in the eye of the beholder'. What to an ordinary man is a lump of clay, for the potter it contains the promise of a beautiful vase. Our budding architect and Rotaract President has presented such a positive and delightful angle to our chaotic streets that it will forever change our own vision of them, from an ugly jumble to a rich tapestry. In architecture, public space is frequently interpreted through parks, squares, or plazas. Yet, for me, the Indian street epitomizes public space in a far richer, multifaceted sense. Unlike the contained spaces of parks or squares, Indian streets are dynamic corridors of interaction, commerce, culture, and daily life. They are not mere conduits for movement but are places where diverse urban activities unfold, making them intrinsic to the fabric of Indian urban life. Indian streets function as socio-cultural spaces where daily life transcends the boundary between private and public realms. Streets here are adaptive, transforming throughout the day and across seasons. In the early hours, they might host vegetable vendors and newspaper stalls, while by midday, street food stalls, makeshift retail shops, and informal workers fill the sidewalks. By evening, they can become bustling bazaars or spaces for religious processions and festivities, turning the urban street into a cultural stage. This fluid adaptability of Indian streets demands architectural understanding that respects their complex, evolving role.

From an architectural perspective, Indian streets challenge traditional definitions of zoning and public space. Here, boundaries between commercial, residential, and religious uses blur, making the street an open, multifunctional space. Architecture interacts with this environment by accommodating a range of activities—through shade-providing awnings, flexible kiosks, or verandas that extend onto the street, creating a shaded, comfortable buffer

between public thoroughfares and private interiors. This flexibility is a testament to vernacular design solutions that prioritize people over rigid zoning laws.

Moreover, Indian streets are places where social stratifications dissolve, at least temporarily. All levels of society use these streets, and interactions among people are inclusive. The chaiwala might share space with corporate employees on a busy Mumbai street, or in Delhi's lanes, shoppers from diverse backgrounds brush shoulders with tourists. These shared spaces foster spontaneous interactions and a sense of community, essential for socially sustainable cities.

Streets in India also reflect architectural resilience. Architectural elements like street-side shrines, banyan trees, and community water points integrate into the urban landscape, providing pauses within the chaos of urban life. These elements are not just functional but spiritual and symbolic, representing continuity amidst rapid modernization.

In essence, Indian streets are the heartbeat of cities—adaptive, resilient, and democratic spaces that embody public life in ways parks and squares cannot. This organic public space model challenges architects and planners to rethink public spaces that resonate with local cultures and accommodate diverse, everevolving activities. By embracing the richness of Indian streets as public spaces, architecture can better align with the vibrant, unplanned, and inclusive spirit of Indian urbanism.
