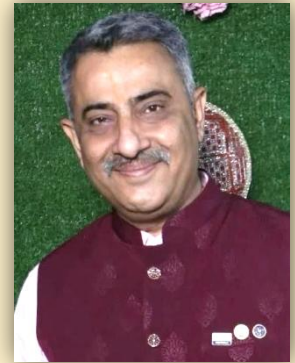

## MEETING DETAILS | Free Lipid Profile Camp

(Held on 28<sup>th</sup> June, 2025 at Darya Ram Hospital)

Rotary club of Sonapat organised its **Monthly Free Lipid Profile Camp** on 28/06/25. **A total of 22 participants got their lipid profile tests done**, those who had elevated cholesterol were advised on follow-up actions or lifestyle modifications.

Focus on making changes to your food, working out regularly, and living a healthy lifestyle to keep your lipid profile in good shape. Some important things to do are to control your weight, eat a heart-healthy diet, do regular physical exercise, and stay away from smoking and drinking too much alcohol.

### 1. Dietary Changes:

- \* Reduce Saturated and Trans Fats: Limit foods high in saturated fats (found in red meat, full-fat dairy) and trans fats (often in processed foods and fried items).
- \* Increase Fiber Intake: Incorporate soluble fiber-rich foods like oats, beans, and fruits, which can help lower LDL cholesterol.
- \* Healthy Fats: Opt for unsaturated fats found in foods like avocados, nuts, seeds, and olive oil.
- \* Limit Cholesterol Intake: While dietary cholesterol has less impact on blood cholesterol than saturated and trans fats, it's still wise to be mindful of your intake.

### 2. Regular Exercise:

- \* Engage in Moderate-Intensity Physical Activity: Aim for at least 30 minutes of moderate-intensity exercise most days of the week.
- \* Incorporate Cardio: Activities like brisk walking, jogging, swimming, or cycling can help improve cholesterol levels.
- \* Weight Management: Regular exercise, along with dietary changes, can help maintain a healthy weight, which is beneficial for lipid profiles.

### 3. Lifestyle Modifications:

- \* Quit Smoking: Smoking can lower HDL ("good") cholesterol and increase LDL ("bad") cholesterol.
- \* Limit Alcohol Consumption: Excessive alcohol intake can raise triglyceride levels.
- \* Stress Management: Chronic stress can negatively impact lipid profiles. Finding healthy ways to manage stress, such as exercise or meditation, can be helpful.

### 4. Regular Monitoring:

- \* Fasting Lipid Profile: Undergo regular lipid profile tests (typically including total cholesterol, LDL, HDL, and triglycerides), usually fasting for 9-12 hours before the test.
- \* Consult Your Doctor: Discuss your lipid profile results with your doctor and follow their recommendations for any necessary lifestyle adjustments or medical treatments

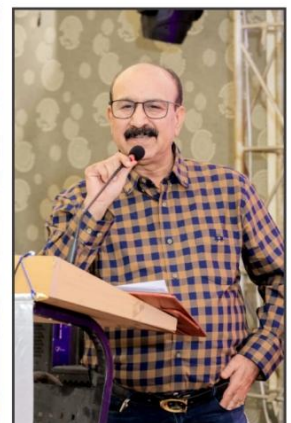

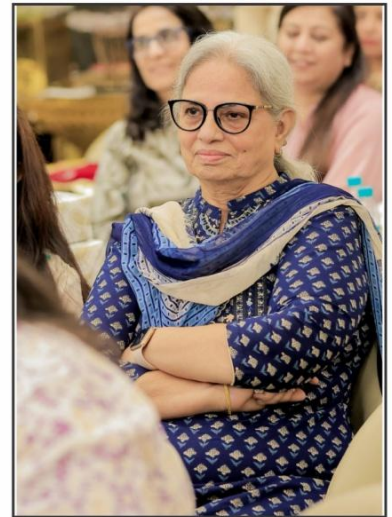

## BYLAWS OF THE ROTARY CLUB OF SONEPAT

### Article 1 Definitions

1. Board: The board of directors of this club.
2. Director: A director on this club's board.
3. Member: A member, other than an honorary member, of this club.
4. Quorum: The minimum number of participants who must be present when a vote is taken: one-third of the club's members for club decisions and a majority of the Directors for club board decisions.
5. RI: Rotary International.
6. Year: The 12-month period beginning 1 July.

### Article 2 Board

The governing body of this club is its board of directors, consisting of, at a minimum, the president, immediate past president, president-elect, secretary, joint secretary, treasurer, vice president, sergeant-at-arms, director-club services, director-international services, director-community services, director-new generations, director-vocational service. As per requirement, maximum of two vice presidents can be included in the board.

### Article 3 Elections and Terms of Office

**Section 1** — One month before annual general meeting, notice for general elections will be sent. Such notice can be sent either through club newsletter or online through e- mail/WhatsApp etc. Members nominate candidates for president-elect, secretary, joint secretary, treasurer, vice president, sergeant-at-arms, director-club services, director-international services, director-community services, director-new generations, director-vocational service. The nominations may be presented by a nominating committee, by members from the floor, or both.

**Section 2** -- For the purpose of elections, nomination committee consisting of reigning President, Immediate Past President and President Elect will be formed. Reigning President will be chairman of the said committee.

**Section 3** — The candidate who receives a majority of the votes for each office is declared elected to that office. Decision of Nomination Committee will be final in this context.

**Section 4** — If any officer or board member vacates their position, the remaining members of the board will appoint a replacement.

**Section 5** — If any officer-elect or director-elect vacates a position, the remaining members of the board-elect will appoint a replacement.

**Section 6** — The terms of office for each role are:

<b>President</b> —	One year
<b>Vice President</b> —	One year
<b>Treasurer</b> —	One year
<b>Secretary</b> —	One year
<b>Joint Secretary</b> —	One year
<b>Director</b> —	One year

**Section 7** - The term of office for a club president is specified as one year in the Standard Rotary Club Constitution. In case President Elect resigns due to any reasons, the current president's term can be extended for up to one year.

## Article 4 Duties of the Officers

**Section 1** — The president presides at club and board meetings.

**Section 2** — The immediate past president serves as a director on the club board.

**Section 3** — The president-elect prepares for his or her year in office and serves as a director.

**Section 4** — The vice president presides at club and board meetings when the president is absent.

**Section 5** — A director attends club and board meetings.

**Section 6** — The secretary keeps membership and attendance records.

**Section 7** — The treasurer oversees all funds and provides an accounting of them.

**Section 8** — The sergeant-at-arms maintains order in club meetings.

## Article 5 Meetings

**Section 1** — An annual meeting of this club is held no later than 31 December to elect the officers and directors who will serve for the next Rotary year.

**Section 2** — This club meets as follows: Every Friday at 8:30 PM. Reasonable notice of any change or cancellation of the regular meeting will be given to all club members.

**Section 3** — Board meetings are held each month. Special meetings of the board are called with reasonable notice by the president or upon the request of two directors.

**Section 4** - In case of any urgent issues, online board meeting can also be held using electronic media like WhatsApp etc. to take decisions. Such decisions will be binding on club members as if taken in regular board meeting.

## Article 6 Dues

Annual club dues are approved every year by general house in 1<sup>st</sup> Club Assembly of respective Rotary Year. Such club assembly should be held within 1<sup>st</sup> fortnight of every Rotary Year. They are paid as follows: In two installments due in July or January.

Annual club dues include RI per capita dues, subscriptions to an official magazine, district per capita dues, club fees, Installation charges, Governor Official Visit charges, Rotaract Installation Charges, Roster Charges, and any other Rotary or district per capita assessment.

## Article 7 Method of Voting

The business of this club is conducted by voice vote or a show of hands except in the election of officers and directors, which is conducted by ballot. The board may also provide a ballot for a vote on some resolutions.

The quorum of any club meeting is one-third of the club's members for club decisions. Club decisions will be deemed to be approved which are consented for 2/3rd of the quorum present.



## Article 8 Committees

**Section 1** — This club's committees comprise those listed in article 11, section 7, of the Standard Rotary Club Constitution, which are as follows:

- (a) Club Administration;
- (b) Membership;
- (c) Public Image;
- (d) Rotary Foundation; and
- (e) Service Projects.

**The board or president may appoint additional committees as needed.**

**Section 2** — The president is an ex officio member of all committees.

**Section 3** — Each committee's chair is responsible for the regular meetings and activities of the committee, supervises and coordinates its work, and reports to the board on all committee activities.

## Article 9 Finances

**Section 1** — Before each fiscal year starts, the board prepares an annual budget of estimated income and expenditures.

**Section 2** — The treasurer deposits club funds in a financial institution/bank or institutions designated by the board. The account such opened will be operated by as per the resolution of the board.

**Section 3** — Bills are paid by the treasurer or another authorized officer and approved by President.

**Section 4** — Financial Statements including details of financial transactions and bank statements etc. will be submitted by outgoing President by 31<sup>st</sup> August of subsequent year.

**Section 5** — A committee consisting of qualified persons, which will be constituted in first club assembly of subsequent year, conducts a thorough annual review of all financial transactions. Audit Report of the same will be submitted by 30<sup>th</sup> September to the board.

**Section 6** — Club members will receive an annual financial statement of the club. A mid- year financial report, with current and previous year income and expenses, is presented at the annual meeting.

**Section 7** — The fiscal year is from 1 July to 30 June.

## Article 10 Method of Electing Members

**Section 1** — A member proposes a candidate for membership to the board and/or the membership committee, or another club proposes one of its transferring or former members.

**Section 2** — A clear 10 days notice for such proposal as approved by the board will be given to the members for raising objections, in any. Such notice can be given either through club newsletter or through online electronic media like WhatsApp etc.

**Section 3** — The board approves or rejects the candidate's membership within 30 days and notifies the proposing member of its decision.

**Section 4** — If the board approves the candidate's membership, the prospective member is invited to join the club.

## Article 11 Amendments

These bylaws may be amended at any regular club meeting. Changing the club bylaws requires sending written notice to each member 21 days before the meeting, having a quorum present for the vote, and having two-thirds of the votes support the change. Changes to these bylaws must be consistent with the Standard Rotary Club Constitution, the RI Constitution and Bylaws, and the Rotary Code of Policies.
