The Do's & Dont's - Property Insurance...by Rtn. Mehernosh Todiwala

After becoming an engineer, I did not join my father's mechanical work-shop which was doing very well. I wanted to do something of my own.

I worked with L&T for more than 10 years and now I am an Insurance Surveyor & Loss Assessor since last nearly 30 years.

HOW TO BECOME AN INSURANCE SURVEYOR

In the present scenario, to become a surveyor one has to enrol himself with a senior surveyor as a trainee, Register himself with IRDAI as well as IIISLA(Indian Institute of Insurance Surveyors and Loss Assessors) as a trainee. The training period is one year. After that you need to give exams conducted by IRDAI/III. Once you pass the exam, you have to take up licentiate membership of IIISLA. After this, you submit your credential to the Insurance companies and show your expertise and knowledge and started getting survey assignments.

MYTHS ABOUT PROPERTY INSURANCE

1. The person selling Insurance may convey that everything is Insured and covered in a particular policy.

Please do not get carried away. All policies have their admissible perils, exclusions, compulsory deductibles and ways of settlement of claim.

2. Lower the Insurance premium, but the Insurance coverage remains the same.

In the current scenario, there should not be much variation in the premium from different insurance companies. We have come across several cases where premium is portrayed as lower, but when the policy is issued the sum insured adjusted and not as desired.

I personally believe this quote "Sharjah could not have built so beautiful Taj Mahal, if he would have considered L1 (lowest quote)". Please do not look at the premium value, but look at the risk covered.

DO'S & DON'T FOR INSURED

- 1. In today's scenario, taking selfies has become very common. Our property also demands selfie. Please take photographs of your property at regular interval. This helps you to prove your case in event of a loss.
- 2. Back-up of your ERP / accounting system should be taken on daily basis and should not be kept at the work place.
- 3. As far as possible keep your accounts up to date (nothing pending for entry).
- 4. Make it a habit to ask concerned person to send a email narrating the days transactions, if possible. This way you are generating a second line of records.
- 5. Do not file your policy before you check it thoroughly. Please definitely check the location (address), items insured with corresponding sum insured, various clauses and attachments to the policy etc.
- 6. You must have a policy which does not exclude "Act of God".
