


WEBINAR ON CANCER CARE HEALTH PLAN

The international partner is Rotary Club of Sarasota Sunrise, USA. The ward was inaugurated and handed over along with two ventilators and other seven

peripheral machines to the hospital with worthy hands of our honorable District Governor **Rtn Prashant Jani**, **Dr Vijay Shah**- President of BJP and Assistant Governor **Rtn Anil Jain** in presence of KGP president **Mr Surendra Doshi**, Secretary **Dr Jagdish Patel**, other doctors and RCBS members at 10:30 am. The event was covered by **VNM** and **Spark TV**.





A little brief about the project is as under:

While Covid – 19 is spread across socio economic strata, this project aims to largely serve economically underprivileged patients (children up to 18 years of age) in Vadodara city and the District, who are Covid – 19 positive or suspected.

The objective of this project is:

- 1) To extend Covid 19 treatment and ICU and NICU capacity by installing ventilators and supporting equipment
- 2) To provide healthcare professionals' safety
- 3) To create awareness in suburbs and slums about social distancing, sanitation/ hygiene (frequent hand wash, using protective mask, etc.) and staying indoors.

Past President **Rtn Chetan Dedhia** has been instrumental in getting the funds as well in executing the entire global grant with help of RCBS team members. We thought of initiating this global grant for Kashiba Children Hospital in the month of June after experiencing the COVID -19 pandemic.

With financial support of the donor - Mr Jayant Sanghvi (term gift of \$30000), IPDG Anish Shah (\$5000 from District Designated Fund), PDG Parag Sheth (\$1575 personal) RC Sarasota Sunrise, Florida - international partner (\$105) and RCBS (\$1066.51); The Global Grant team has been relentlessly working for the project since then and this day will be mentioned in golden words in the history of RCBS. PULMONARY FUNCTION TEST

26TH AND 30TH DECEMBER 2020



RCBS conducted Pulmonary Function Test for lungs and Thyroid Testing and checkup camp in collaboration with Ganga Jamna Hospital on 26th and 30th December respectively. PFT for lungs is generally done for post Covid treated patients as well as patients with Asthama and other breathing and lungs related illness. Thyroid disease is a medical condition that affects the function of the thyroid gland. The thyroid gland is located at the front of the neck and produces thyroid hormonesthat travel through the blood to help regulate many other organs, meaning that it is an endocrine organ. These hormones normally act in the body to



regulate energy use, infant development and childhood development.


THYROID TEST CAMP

RCBS Project HUMF and Rotary Focus area of Material health and child care:

How the project HUMF of RCBS has been effective and RCBS is working wonderfully in this focus area of mother and child care and nutrition: Good nutrition and health care before a child's second birthday are vital to their future.

Most new parents mark their baby's progress in a series of milestones: first smile, first word, first steps. But pediatricians are focused on a milestone that might be less familiar: the first 1,000 days.

The phrase is shorthand for the period between conception and a child's second birthday, a critical time frame when nutrition, or lack thereof, can have lifelong consequences. Research in child development has shown that when mothers and infants are poorly nourished during this stage, the adverse impact on children's physical and mental development can have ripple effects throughout their lives. And much of that damage can never be undone, even with later interventions.

Children who get the right nutrition in the first 1,000 days:

- Are more likely to be born at a healthy birth weight
- Have a lower risk of many conditions and diseases, including obesity and type 2 diabetes
- Go on to be better learners with fewer behavior problems in kindergarten
- Enjoy improved health and economic security as adults

The 10 building blocks for nutrition during the first 1,000 days

- A nutritious diet for mothers during pregnancy
- Exclusive breastfeeding for the first six months
- The right foods introduced to babies at the right times
- Paid time off for working parents to care for their newborns
- Consistent access to enough nutritious food for families of young children
- Good care for all mothers during pregnancy
- Nurturing, responsive care and feeding of babies and toddlers
- A healthy and nutritious diet for babies and toddlers
- The right knowledge and skills for parents and caregivers to properly nourish young children
- Societal investments in the well-being of every baby and toddler



DISTRICT 3060 featured in Rotary India magazine

Our District Governor's article on Swamaan Store and various other projects had been featured in Rotary India.

Till October, 22 Swamaan stores have been opened across district 3060 to give dignity to poor families and give them utility products. These collected, repaired and repacked products are sold at modest rates of 20-100 rupees. He has also mentioned that around 1000 hand wash stationswill be installed this year in schools and public places. Two cancer detection vans for mammography, Pap smear and oral cancer tests will screen around 75000 beneficiaries. A Mega rally from Somnath to Dhulewill be flagged off in February to cover all the permanent projects of the entire district.

Did You Know?

THE CLASSIFICATION PRINCIPLE



Virtually all membership in Rotary was based upon 'classification'. Basically classification describes the distinct and recognized business or professional service which the Rotarian renders to society.

The principle of Rotary classification is somewhat more specific and precise. In determining the classification of a Rotarian it is necessary to look at the "principal or recognized business or professional activity of the firm, company or institution" with which an active member is connected or "that which covers his principal and recognized business or professional activity." It should be clearly understood that classifications are determined by activities or services to society rather than by the position held by a particular individual. In other words, if a person is the

president of a bank, he or she is not classified as "bank president" but under the classification "banking."

It is the principal and recognized activity of a business or professional establishment or the individual's principal and recognized business or professional activity that determines the classification to be established and loaned to a qualified person. For example, the permanently employed electrical engineer, insurance adjuster, or business manager of a railroad company, mining company, manufacturing concern, hospital, clinic, etc., may be considered for membership as a representative of the particular work he or she may be doing personally or as a representative of the firm, company, or institution for which the professional service is being done.

The classification principle also permits business and industries to be separated into distinct functions such as manufacturing, distributing, retailing and servicing. Classifications may also be specified as distinct and independent divisions of a large corporation or university within the club's territory, such as a school of business or a school of engineering.

Though the classification principle is not as dominant as it once was it is still important that we make an effort to assure that each Rotary club represents a cross section of the business and professional service of the community.
